Sub: Complain for starting a specific case.

In producing herewith the arrested accd persons namely (1) Akash Dutta (21 yrs) S/O-Trilochan Dutta of vill-Bagda PS-Puncha Dist-Purulia (2) Sourav Kaibartya (19 yrs) S/O-Kartick Kajbartya of vill-Bagda PS-Puncha Dist-Purulia (3) Manas @ Bom Mahato S/O Lt. Gouranga/Mahato of vill-Pandui PS-Puncha Dist-Purulia along with all connected papers.

I beg to submit that on 07/10/2021 at about 11.35 hrs I PSI Sandip Pal along with ASI Anup roy, C/752 Durjodhan Sing Sardar & HG/1846 Panchanan Mahato, all of Puncha PS Dist-Purulia were performing naka checking near Budhpur bridge under Puncha PS vide Puncha PS GDE No.-275 & CC No.-2581/2021, suddenly a motorcycle bearing no.-WB56D/1752 was coming in rash and negligent manner from Budhpur side, which carried 03(three) persons. We tried to stop the said motorcycle to check the valid documents regarding the said motorcycle but they did not pay any heed to our words and crossed the naka checking point at Budhpur bridge, also used slang "Mother f***er" towards us. After a while the said motorcycle along with the said riders was returning back to the same way. At that time we were able to stop the said motorcycle and asked them to show the valid documents of the said motorcycle. They started arguing without showing the papers and threw the compound slips alongwith arrest memo. We tried to detain them but the above noted persons assaulted us, pushed C/752 Durjodhan Sing Sardar & ASI Anup Roy. Above noted Manas @ Bom Mahato snatched the keys of the Govt vehicle bearing no.-WB42S/1505 from the driver CD/1022 Satya Narayan Gorain's hands and pushed him. The above noted micreants were heard saying that "aaj sala police ke merei felbo jaate bhobisyote kono dino amader badha na dite pare.... Mere fel sala der ke, sala akbar murder korechhi abar korbo, court amader kichhu korte parbe na" and used filthy languages to us. Being in police uniform I along with other officer and forces tried to stop them but they did not pay heed and continued their assault, refrained us from performing govt duty. As a result C/752 Durjodhan Sing Sardar, ASI Anup Roy sustained injuries on their persons. Accordingly I seized the motorcycle bearing no.-WB56D/1752 from the possession of Manas @ Bom Mahato S/O-Lt Gouranga Mahato of vill-Pandui PS-Puncha Dist-Purulia under proper seizure list duly signed by him and other available witnesses and arrested the above noted accd persons after check list which is enclosed herewith and brought them to PS. The whole incident took place in between 11.45 to 12.55 hrs.

Under such situation I pray that a specific case may kindly be started u/s- 186/332 /353/506/34 IPC against all the above mentioned accd persons.
