Respected Sir,

In producing herewith the arrested accused persons namely Dipak Barik (20/M) S/O Ghasiram Barik of Jamda, PS-Barajamda, Dist- West Singhbhum Jharkhand and Tanuj Barik (23/M) ^{S/O Snipati Barik} of Do along with copy of Arrest Memo/ Inspection Memo before your custody. I, SI Gopika Sundar Dutta presently posted at Sadar Traffic as In-Charge, would like to draw your kind attention regarding the incident that, today (01.10.2021) while myself along with NVF/619 Jagabandhu Mitra, HG/1397 Kushadhvaj Mahato vide Purulia Sadar Traffic GDE No 08 dtd. 01.10.2021 were engaged in restriction on movement of goods vehicles through Purulia Town area as per order of DM, Purulia vide Memo No 210/(8)/MV Dtd. 23.09.2021 to prevent any untoward incident in ensuing Durga Puja Festival-2021, that time received an information from my staff detailed at no entry point at Judge Banglow Morh that 02 (two) loaded trucks bearing Reg. No **OD09K-3211 & OD09K-3511** proceeded through Purulia Town area after violation of Traffic rules at that point. Accordingly I informed my staff detailed at Bhangra Morh Interception and diversion point to detain the said trucks. While I reached at Bhangra Morh at about 06:30 PM noticed that both driver and helper of both trucks bearing Reg. No **OD09K-3211 & OD09K-3511** engaged themselves in hot altercation with my staff. I asked them the reason of violating No entry rules that time all of them suddenly attacked upon me, confined me wrongfully and also assault me with fist and blows and deter me to perform my lawful Govt. Duty. As a result I received injury on my head and chest. On duty CVFs and my staff were the witnessed of this incident and while they rescued me that time both driver & helper fled away from the spot. After hot chase we were able to detain two of them on asked they disclosed their identity as Dipak Barik (20/M) S/O Ghasiram Barik of Jamda, PS-Barajamda, Dist- West Singhbhum Jharkhand and Tanuj Barik (23/M) of Do. Accordingly I arrested them after observing all legal formalities of arrest. Prepared Memo of arrest on spot searched their persons but found nothing except wearing apparels. There after I arranged for their Medical treatment at Purulia Govt. Medical College & Hospital.

Under this circumstance I therefore requesting to you to treat my complaint as FIR and arrange for its investigation.
