**The Inspector-in-Charge of Purulia (M) PS,
Dist-Purulia.**

Sir,

Today (04.10.2021) at about 09:05 hrs. while I along with force were performing RT Mobile duty towards Hura-Barakar Road (NH-314) as per detailment and received an information from duty officer of Purulia (M) PS namely ASI Ajoy Mukherjee that some local villagers of Gengara village obstructed the National High way road (NH-314) at Gengara School morh regarding their various demands such as to get benefit of PMAY Abash Yojona and Countervail/ Compensate for house which was damaged by natural calamities of last Gulab storm and heavy rain fall.

After receiving the information immediately, I along with force as (i) C/2895 Goutam Betal, (ii) NVF/0068 Mahanta Mahato all of Purulia (M) PS vide C.C. No 2920/21 and GDE No 131, Dt. 04.10.2021 rushed to the spot at about 09:35 hrs. and found approx. 100-110 mob mostly women obstructed the said NH-314 road (Purulia-Bankura) at Gengara School Morh on their various demands resulting huge number of vehicles, Ongoing passenger buses, Trucks and other vehicles were stopped due to said road blocked. I along with force requested and tried to our best for withdraw the said road blocked but the female under the leadership who lead the blocked whose identity I came to know from the local villagers as (i) Rukmoni @ Tulu Mahato W/O Pradip @ Pintu Mahato (ii) Hebi Bauri W/O Manik Bauri (iii) Mamata Rajak W/O Pradip Rajak (iv) Santi Bauri W/O Pannalal Bauri (v) Himani Bauri W/O Basudeb Bauri under the leadership of Pravash Rajak S/O Kharu Rajak and Asish Mahato S/O Sabyasachi Mahato all of Village Gengara under Purulia (M) PS, Dist-Purulia (W.B) along with others approx. 100-110 after forming unlawfully assembly. They demanded that without the presence of BDO Block-II Purulia, on the spot they will not withdraw the said road block. I inform the matter in my Inspector in-Charge who along with force and officer came to the spot and have conversation with the above noted mob mostly women and leaders to withdraw the road blocked. After that the staff of BDO office Block-II, Purulia (Join-BDO, Block-II, Purulia Chanchal Kumar Mandal and Partha Sarathi Mandal BDMO of BDO office Block-II, Purulia) arrived the spot. But they were very much adamant on their demand and not to the withdraw the road blocked. When we requested withdraw the blocked, the aforesaid female under the above noted leadership asked to the BDO to come on the road for discussion regarding their demands. Subsequently vehicular traffic was totally disrupted and seized along the Purulia-Bankura road (NH-314). Ongoing buses, Trucks and other vehicles were stopped. We requested the above noted leaders as well as road blocker mostly women but they paid no heed to our words. We persuaded further and tried to convince the agitators that the road is one of the busy public lines of navigation of this district which should not be blocked but they denied our proposal and deter our duty. I along with force started to disperse them form the road but the road blockers obstructed them adamantly from the discharge of our public functions. After the prolonged discussion and request the mob withdrew the road blocked at about **12:45 hrs.** Thereafter, the vehicular traffic movement became normal after our assiduous act. Therefore I request you kindly lodge a specific case **U/S-143/341/34 IPC & 8B of National Highway Act- 1956** under the leadership of supra noted persons ergo in whose act causes totally disrupted the vehicular traffic for the 03 hrs. above. So a specific case may kindly be initiated against them in above noted section of law and arranged for its investigation.
