Sub: **Complaint against Biswanath Kumbhakar (35 Yrs) s/o Saktipada @ Fuchu Kumbhakar of Vill- Narrah, , PS- Purulia (M), Dist- Purulia to start a cog case u/s 46 A (c) of Bengal Excise Act. 1909.**

Sir,

In producing herewith one arrested accd. person namely Biswanath Kumbhakar (35 Yrs) s/o Saktipada @ Fuchu Kumbhakar of Vill- Narrah, , PS- Purulia (M), Dist- Purulia with seizure list and seized articles.

I beg to submit that today (07.10.2021) while I was detailed to perform Spl. duty in PS area along with force i) C/1175 Srikanta Mukherjee (ii) SPL HG/Ghanaram Kumar of Purulia (M) PS & Purulia (M) PS C.C. No 2968/2021 Dt. 07.10.2021 and GDE No 269 Dtd. 07.10.2021. During my mobile duty, I received a secret tip off that an illegal possession of huge amount of Country spirit. Subsequently, I informed you and as per your direction, I rushed to the spot that is Narrah village and after arriving at the spot and as per instruction conducted raid in the Pan Stall of Biswanath Kumbhakar under this PS at 16:15 hrs. During the raid 2/3 persons fled away near the Pan Stall and detained one person. On asking the identity he disclosed his name address as noted supra. On interrogation he confessed that he possessed the Country spirit for selling illegally from his Pan Stall so that he could gain more amount from the selling of (liquors) Country Spirit. On demand he failed to produce any valid document in respect of selling and possession of said (liquors) Country Spirit at his Pan Stall. Subsequently, I seized (i) 21 (Twenty one) sealed bottles liquors of country sprite each containing 300 ml., MRP 25/- per bottles which is styles as "Dil Khush" and kept 01 sealed bottles as sample from 21 (Twenty one) bottles (ii) One Plastic container which containing approx. 04 (four) ID liquors (Illicit Distilled Liquor) under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. Consequently, I arrested the above noted accused person after informing him the ground of arrest and issued Memo of Arrest and observed all legal formalities in respect of the Arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted arrested person Namely Biswanath Kumbhakar (35 Yrs) s/o Saktipada @ Fuchu Kumbhakar of Vill- Narrah, , PS- Purulia (M), Dist- Purulia committed offence U/S 46 A (c) of Bengal Excise Act. 1909 for unauthorized possession for selling of Country Spirit from his Pan Stall. Under the fact and circumstance kindly take necessary lawful action against Biswanath Kumbhakar (35 Yrs) s/o Saktipada @ Fuchu Kumbhakar of Vill- Narrah, , PS- Purulia (M), Dist- Purulia.
