Let this petition U/S 156(3) Cr.P.C be referred to O/C, Purulia (M) P.S, District Purulia for treating this petition as F.I.R.

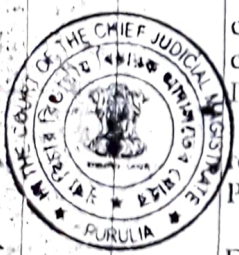

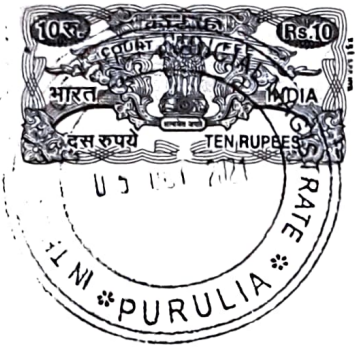

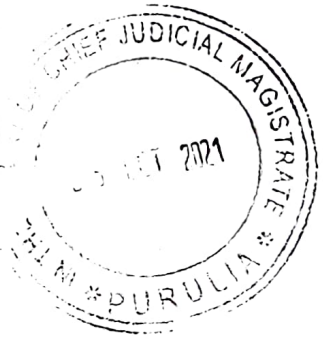

- 1. That the Complainant Jagdish Dutta son of Gopa Dutta is a permanent resident of Village - Dimdiha.
2. That on 12.09.2021 the Complainant and his friends i.e. Witness nos. 2 to 5 planned to visit to Laljora (Hatikheda) for the purpose of performing Puja.

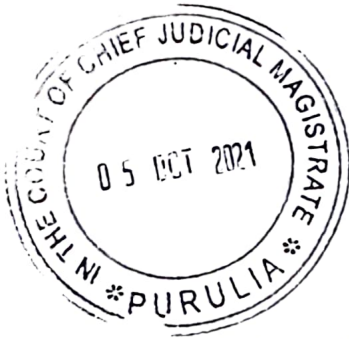

3. That the Complainant boarded a Tempo to go the Laljora (Hatikheda) and it was agreed and undertook in between the Complainant and the Tempo Driver i.e. the Accused Person that they would go to Hatikheda and after reaching out there the Complainant would perform Puja and after performing Puja they will return to the Village Dimdiha.
4. That in lieu of the said agreement in between the Complainant and the Driver, the Driver charged Rs. 1600/- as fare to go to Hatikheda and to return to Village - Dimdiha to which the Complainant agreed and out of Rs. 1600/- the Complainant paid Rs. 400/- to the Driver as advance.
5. That after reaching at the place of worship, the Complainant and his friends kept their personal articles in the Tempo and entered Hatikheda Temple for the purpose of performing Puja.
6. That after performing Puja when the Complainant along with his friends came to board the Tempo, at about 6 P.M. in the evening the Complainant to his utter surprise found that the Tempo Driver has fled away along with the Tempo. It is pertinent to mention here that the Complainant had kept articles like Bag, watch and his purse on the Tempo and the Driver stole the said things most illegally and wrongfully. The registration number of the said vehicle/Tempo is JH09A V9759.
7. That finding no other alternative the Complainant called the Driver over mobile phone and asked him to come to fetch him the Driver refused to come and threatened the Complainant with dire consequences and also abused the Complainant in gutter and filthy languages.

8. That the Driver stole articles like Bag, Watch and a purse of Complainant and also money amounting to Rs. 1700/- and left the Complainant at a strange place with a mala fide intention with a view to endanger the life of the Complainant.
9. That friends of the Complainant who are witness no. 2 to 4 who also went to Hatkheda to perform Puja witnessed the entire occurrence.
10. That after the said incident the Complainant somehow managed to return to Village Dimdiha along with his friends and they intimated the said facts before the concerned Purulia (M), P.S.
11. That on 13.09.2021 the Complainant lodged a written complaint before the Police but the I.C. attached to the Thana refused to register F.I.R. and/or to give any G.D.E. Entry for which the Complainant sent his letter of complaint by registered post.
12. That when the concerned P.S. did not take any step the Complainant also filed an information before Superintendent of Police, Purulia.
13.
