I ASI Ajoy Mukhopadhyay (49 yrs) presently posted at Purulia (M) PS under your kind control, would like to draw your kind attention regarding the incident that, today (27.10.2021) while myselfglong with C/692-Ukil Ch. Mahato, Hg/1576-Shakti Mahato of Purulia (M) PS, vide Purulia (M) PS C.C No-3251/2021 and GDE No 1040 dtd. 27.10.2021 were engaged mobile duty towards Hura & Barakar road side and as per order of I/C Purulia (M) PS were checking the Naka near Bharat Super cement factory on the way to Purulia -Raghunathpur Road at about 13:35 hrs. I found one truck (Mini Dumper) vide its registration No- WB67A-9629 was coming from Purulia side in high speed & I signed to stop him & asked to produce the valid documents of the aforesaid vehicle. But he (driver) did not show any papers and started hue and cry also abused me in filthy languages and rather than called another persons to reach at the spot. Meanwhile two persons those who were introducing themselves as 1). Amit Ghosh, Purulia District Truck owner's Association Secretary as well as Vice President of West Bengal truck owner's Association & 2). Ghadhu Kheriya@Ghadhu Babu under Purulia (T) PS area & stand their motorcycle (scooty) in front of our Mobile vehicle in an unfair manner which causes to stop movement of our vehicle & both of them started arguing at about 14:00 hrs. At that time both of them suddenly attacked upon me restrained wrongfully and challenge my authority to check the vehicle and also assault me with fist and blows and deter me to perform my lawful Govt. Duty. As a result I received injury on person and on duty my staff were the witnessed of this incident and while they rescued me that time both of them fled away from the spot after threatening. After hot chase we could not able to detain. There after I arranged for my Medical treatment at Purulia Govt. Medical College & Hospital.

Under this circumstance I therefore requesting to you to treat my complaint as FIR and arrange for its investigation.
