Today on 30.10.2021 at about 13:05 hrs, information was received that Bharatiya Janata Party will take out a rally from Jubilee Maidan under Purulia (T) P.S. As per instruction of I/C Purulia (T) P.S., I along with other officers and force including lady constable reached there and saw a huge gathering of about 250- 300 affiliated to Bharatiya Janata Party assembled at Jubilee Maidan violating all norms of Covid protocols. We requested them for dispersing from there

immediately by public addressing system and other means. But they paid no heed to the same. Further, under the leadership of the above named 34 (thirty four) persons they took out a rally from Jubilee Maidan to Taxi Stand both under Purulia (T) PS without any permission and also assembled at Taxi Stand for party meeting violating all the protocols as laid down by the Central Govt. and State Govt in c/w Covid-19.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the Central Govt. & the State Govt. has passed an order to wear mask in the public place is mandatory and ordered to prosecute the defaulters. They violated the order duly promulgated by the government through public servants and through media etc for prevention of spreading of CORONA Virus/COVID-19. They were creating annoyance to the society & violated the govt. order. Though in view of Pandemic of COVID-19 outbreak vide Govt. of India order No- 79-CS/2020 dated 12.04.2020 and order No- 753/X-ISS/2M-22/2020 dated 30.09.2021 of the Government of West Bengal, Wearing of facial mask has been mandatory in public places in the current pandemic disaster situation. Whereas, vide advisory issued vide no- 715-Home (Cons)/RIM(Cons)-92/2021 dated- 17.04.21, Government of West Bengal has stressed that any violation of mask and social distance norms should be strictly dealt with.

Hence, I pray before you to start a specific case against the above noted persons and 250/300 others under proper section of law.

So I request you for starting a case and, also for arranging its investigation.
