l, Rajkumar Paramanik , Son of Swapan Paramanik, am employed as a manager at Pearltree Hotel, situated at Desbandhu Road, Purulia under the jurisdiction of your police station.

Yesterday, i.e. on 14/10/2021, on the auspicious day of Mahanavami, during normal business hours of our hotel at around 11:15 P.M. at night one Pradip Rajwar, Son of Biru Rajwar, resident of Dhabgata, Jaltanki, and 3/4 others came up and entered the rooftop SKY Lounge of our hotel. From his appearance he appeared to be totally drunk.

After having a few drinks in our rooftop lounge he started disturbing adjacent guests including female guests and started creating nuisance. I was on duty and some guests complained about his behavior and therefore I had to speak to him. I politely requested him to leave from our premises.

On being requested to leave, he immediately started vandalizing our furniture and threw chairs. He injured other guests and staff members also.

When I tried to request him to stop, Pradip Rajwar held me by my throat and arms and grabbed a whisky bottle from our bar counter and with an intention to kill me threw the bottle towards my head.

I was successful in moving aside and freeing myself from the grip of Pradip Rajwar and the therefore the bottle landed on the ground instead of my head. Thereafter, on raising an alarm, the above-named person fled from the scene. At the time of leaving the premises, the above-named person threatened us that he would not spare our lives if he catches us in public place.

The injured staff members were in a lot of pain and therefore we had to close the premises for the night and the staff members were provided necessary first aid immediately and were thereafter medically treated.

I request you to register this complaint as a First Information Report and take necessary steps against the above-named accused person.
