That the complainant most respectfully beg to state as follows:-

- that the complainant is the resident of Mondokdanga, P.O.-Moutore, P.S.- Raghunathpur, Dist.- Purulia West Bengal, within the jurisdiction of your Id. Court.
- that on 01/06/2021 at about 5.00 A.M. when the complainant was at his cultivating land, engaged two labours namely Jogai Bouri & Bachan Bouri, for plow, at that time four persons namely (i). KALACHAND BOURI, S/O. GOPAL BOURI, (ii). SANDIP BOURI S/O. KALACHAND BOURI, (iii). PAGAL BOURI S/O. Lt. KISTO BOURI & (iv). MAKAR BOURI S/O. NEPAL BOURI, all are resident of village Mondokdanga, P.O.- Moutore, P.S.- Raghunathpur, Distt.- Purulia, W.B., came there and started to abuse the complainant with filthy languages and questioning him about engaging labours over his land, and on being protest by him, they started to

assault him and on hue and cry, the engaged labours came to rescue him from them, and at that time, one of the accused person namely SANDIP BOURI, try to assault him with Kural, and at that time when said SANDIP BOURI inflict Kural on him to kill, at that time JOGAI BOURI pushed the complainant and where said JOGAI BOURI got the Kural Assault on his head, and sustain serious and grievous bleeding injury in head and fell down on earth and after that all the above named four persons fled away from there. The complainant and said BACHAN BOURI, took him to BANDA BPHC, where he was medically treated for serious head injury with direction of CT Scan of Brain and also referred to Higher Medical Center for treatment.

3. That on the same day (01/06/2021), the complainant went to Raghunathpur Police Station, where the concerned police authority recorded his statement to lodge the complaint, and assured him that police will registered case against the above named accused persons, but later on 10/08/2021, the complainant came to know that the police has drawn a case under section 107 CrPC, vide Raghunathpur P.S. NCR no.- 1288/21, NGR no.- 669/21 with the name of four persons namely KALACHAND BOURI, PAGAL BOURI & SANDIP BOURI and by leaving the name of another accused MAKAR BOURI the name of his sister JYOTSANA BAURI has been recorded as one of them, and also police has started a proceeding under section 107CrPC against the complainant and two others.
4. That on 13.08.2021 and 17/08/2021, the complainant again went to Raghunathpur Police Station to enquire the matter stated above, but inspite of justice, he had again received two summons U/S. 107 CrPC vide Raghunathpur P.S. NCR no.- 2039 & 2025 corresponding to NGR no.- 803/21 & NGR no.- 790/21, pending before Id. SDEM, Raghunathpur.
5. That from the above facts stated above, it is transpire that complainant is sustaining great injustice.
6. That the complainant had made application to Superintendent of Police, Purulia, duly received on 26/08/2021, but till to-day there is no any fruitful result.
7. That finding no other alternative, the complainant have to take shelter before the Id. Court for the redressal of her grievance.
