Sir,

With due respect I beg to submit before you that on 27/10/2021 at about 23:05 hrs. while I, SI Indrajit Sarkar along with C/185 Rajesh Kr Ray, C/1267 Nabin Patra & C/847 Uttam Hazra vide CC No 2660/21 dated- 27.10.2021 were engaged on night mobile duty in Raghunathpur Town area and found the following persons were moving at Raghunathpur Traffic more aimlessly and not wearing mask in this pandemic situation and violation of social distancing, as such I detained them on that spot. On being asked the following persons could not able to give any satisfactory answer for that moving aimlessly without mask in this pandemic situation and violation of social distancing. As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19 vide No. 753/X-ISS/2M-22/2020 dated- 30.09.2021 and they are responsible for their negligent Act and malignant Act likely to spread infection of disease dangerous to life. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and brought them to PS.

- 1) Tilaknath Deb Barman (22) S/o Jagadish Deb Barman of Vill.- Panchudanga, PS – Adra, Dist.- Purulia.
- 2) Ujjal Banerjee (30) S/o Haradhan Banerjee of Raghunathpur Ward No 13, PS – Raghunathpur, Dist.- Purulia.
- 3) Astik Majee (46) S/o Late Jitendranath Majee of Nanduara, Ward No 9, PS – Raghunathpur, Dist.- Purulia.
- 4) Aktar Khan (35) S/o Eklash Khan of Vill.- Hariharpur, PS – Para, Dist.- Purulia.
- 5) Subhojit Deoghoria (47) S/o Late Mihir Kumar Deoghoria of Vill.- Chinpina, PS – Raghunathpur, Dist.- Purulia.
- 6) Ravi Thakur (32) S/o Naresh Thakur of Vill.- Arrah, PS – Adra, Dist.- Purulia.
- 7) Bittu Prasad (28) S/o Sambhu Prasad of Loco Colony, near Sai Mandir, PS – Adra, Dist.- Purulia.

Hence it is prayed before you that a specific case may kindly be lodged against the above mentioned persons under proper section of law.
