

Respected Sir,

I , SI Subrata Patra S/O Shri Bimal Patra of Vill. Ishabpur, P.S Belda, Dist. Paschim Medinipur do hereby produce (1) Shiba Prasad Dhibar (26yrs) S/O-Lt. Robilochan Dhibar of Vill-Muradi, (2) Sumit Bauri @ Amit (20 yrs) S/O-Lt. Gouranga Bauri of Vill-Sunuri, (3) Nejamuddin Sekh (35 Yrs) S/O- Ismail Sekh of Vill-Murulia, (4) Tapas Mahato (33 Yrs) S/O-Habulal Mahato of Vill-Hansdima all are PS-Santuri, Dist-Purulia, & do hereby lodge a written complaint against them, to the effect that today on 22.10.2021 while I along with C/1452 Sadhan Ch. Kar & HG/1721 Dinesh Mandal of Santuri PS as per direction engaged in mobile duty within Santuri PS area, (Reference Santuri P.S. C.C No. 3872/21 & G.D.E. No. 771, dtd. 22.10.2021) for implementation of Government rules regarding Disaster Management Plan. On 22.10.2021 while we were returning from Marbedia side under Santuri P.S. jurisdiction and reached at Hansdima morh at about 23:05 hrs. found that the above noted 04(Four) persons were gossiping near Hansdima morh without wearing mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule (Memo No.-753/IX-ISS/2M-22/2020 Dated- 15th September 2021 Government of West Bengal 'Nabanna' 325, Sarat Chatterjee Road Howrah- 711102). So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused persons (1) Shiba Prasad Dhibar (26yrs) S/O-Lt. Robilochan Dhibar of Vill-Muradi, (2) Sumit Bauri @ Amit (20 yrs) S/O-Lt. Gouranga Bauri of Vill-Sunuri, (3) Nejamuddin Sekh (35 Yrs) S/O- Ismail Sekh of Vill-Murulia, (4) Tapas Mahato (33 Yrs) S/O-Habulal Mahato of Vill-Hansdima all are PS-Santuri, Dist-Purulia under proper sec. of law as they disobeyed/ignored Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
