Respected Sir,

In producing herewith one arrested accused person namely Bisheswar Mahato (21 yrs) S/O- Nimai Mahato of Vill- Turuhulu, P.S- Tamna, Dist - Purulia with seizure list and seized articles, I beg to submit that today i.e on 07.10.2021 at about 19:05 hrs during Special mobile duty, received a secret source information and as per order of O/C Tamna PS, I PSI Surajit kumar Das of Tamna PS along with force had been to Turuhulu village under Tamna PS at 19:35 hrs and as per indication conducted raid in the house of Bisheswar Mahato (21 yrs) S/O- Nimai Mahato of Vill- Turuhulu, P.S- Tamna, Dist.- Purulia and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession ID Liquor. On demand he failed to produce any valid documents in respect of stock and selling of said ID Liquor at his house. As such I seized Three Jars of ID Liquor each containing approx 05 (Five) Liters ID Liquor, some portion (Approx One Liter) of ID Liquor as sample under proper Seizure List in presence of witnesses duly signed by them and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and labeled in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Bisheswar Mahato (21 yrs) S/O- Nimai Mahato of Vill- Turuhulu, P.S- Tamna, Dist - Purulia committed offence u/s- 46 A(c) B.E. Act- 1909 for unauthorized possession and sales of ID Liquor from his house.

Under the fact and circumstances kindly take necessary lawful action against Bisheswar Mahato (21 yrs) S/O- Nimai Mahato of Vill- Turuhulu, P.S- Tamna, Dist.- Purulia.
