Respected Sir,

In producing herewith one arrested accused person namely Prasenjit Paramanik @ (36 yrs) S/O- Manik Paramanik of Vill- Sonajuri, P.S- Tamna, Dist - Purulia with seizure list and seized articles. I beg to submit that today i.e. on 07.10.2021 at about 18.45 hrs during special mobile duty, received a secret source information and as per order of O.C. Tamna PS. 1 SI Bikash Chandra Patra of Tamna PS along with force had been to Sonajuri village under Tamna PS at 19.25 hrs and as per indication conducted raid in the house of Prasenjit Paramanik @ (36 yrs) S/O- Manik Paramanik of Vill- Sonajuri, P.S- Tamna, Dist - Purulia and found 2-3 persons fled away from his house and detained one person. On asking his identity he disclosed his identity as noted above. On interrogation he confessed his guilt for selling and possession of country spirit styled as DILKHUSH. On demand he failed to produce any valid documents in respect of stock and selling of said country spirit at his own house. As such I seized (i) 12 (Twelve) sealed Bottles of country spirit styled as DILKHU SH each bottles contains 600 ml., (ii) 26 (twenty six) sealed Bottles of country spirit styled as DILKHU SH each bottles contains 300 ml. One bottles taken from each country spirit styled as DILKHU SH of 600 ml. 300 ml. as sample under proper Seizure List in presence of witnesses and signed by witnesses and accused person. Arrested the above noted accused person after observing all legal formalities regarding arrest. Informed him the ground of his arrest. The seized articles were properly sealed and label in presence of witnesses duly signed by them and accused person.

The above noted accused person namely Prasenjit Paramanik @ (36 yrs) S/O- Manik Paramanik of Vill- Sonajuri, P.S- Tamna, Dist - Purulia committed offence u/s 46 (Mc) B.E. Act- 1909 for unauthorized possession and sales of country spirit (DIL KHU SH) from his house.

Under the fact and circumstances kindly take necessary lawful action against
