(3) Samar Kumar (20 Yrs) S/O- Bijay Kumar of Vill- Tetlo, PS- Balarampur, Dist- Purulia, (4) Adesh Gorain (21 Yrs), S/O- Gholtu Gorain of Vill- Uparkahan, PS- Joypur, Dist- Purulia, (5) Sampad Majhi (21 Yrs) S/O- Sankar Majhi of Vill- Tetlo, PS- Balarampur, Dist- Purulia under proper section of law as they ignored the norms of Govt. of India as well as Govt. of West Bengal and committed negligent Act. likely to spread infection of diseases dangerous to life and arranged for its investigation.
