Sir,

I, SI Bikash Ch. Patra S/O- Lt. No. 1155 dtd. 27.10.2021) for implementation of Government rules of Disaster Management Plan reached at Simulia More under Tamna PS at about 23:05 hrs. and found that the above noted 05(Five) persons were gossiping without wearing mask and not maintaining physical distancing which violates the compliance of norms of wearing of mask and maintaining physical distancing during this pandemic situation in e/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing mask and not maintaining physical distancing which violates the compliance of norms of Govt. of India as well as Govt. of West Bengal during this pandemic situation and committed negligent act likely to spread infection of diseases which dangerous to life. So, I have arrested them maintaining all legal formalities as well as notifying the ground of their arrest.

Therefore, I pray a specific case may kindly be started against accused (1) Uma Charan Das Goswami (25 Yrs), S/O- Ambuj Das Goswami of Vill- Sarengdih, PS- Bagmundi, Dist- Purulia, (2) Mansanta Lohar (22 Yrs), S/O- Saranan Lohar of Vill- Haridih, PS- Bagmundi, Dist- Purulia, (3) Md. Sagir Ansary (41 Yrs) S/O- Lt. Md. Tayeb Ali of Vill- Gosidih Kasitard, PS- Tundi, Dist- Dhanbad, Jharkhand, (4) Habib Midya (45 Yrs), S/O- Sabed Midya of Vill- Dhagaria, P.O- Hamirpur, PS- Patrasayer, Dist- Bankura, (5) Ashok Mahato (31 Yrs) S/O- Purna Chandra Mahato of Vill- Murugura, P.O- Berada, PS- Balarampur, Dist- Purulia, under proper section of law as they ignored the norms of Govt. of India as well as Govt. of West Bengal and committed negligent Act. likely to spread infection of diseases dangerous to life and arranged for its investigation.
