Respected Sir,

In producing herewith 02 (Two) accd. persons namely (1) Sk. Azad (21 Yrs) S/o S.K. Akbar Ali (2) Akbar Ali (51 Yrs) S/O Sk. Alamgir both of Vill- Kantaranguni, Kashipur Road, PS- Adra, Dist- Purulia along with seized articles (1) 20 packets of King Cobra electric creekers (Fire Crackers) (2) 40 packets of Panda Bijli creekers (Fire Crackers) (3) 60 packets of Joy Sarathi Bijli creekers (Fire Crackers) (4) 05 packets of Lovely Two Sound (Fire Crackers) (5) 28 packets of Krishna Brand two sound (Fire Crackers) (6) 100 piece wall throwing creekers (Fire Crackers) (7) 14 packets Ground Chakkar (Fire Works) (8) 10 packets of flower Pots (Big) (Fire Works) (9) 03 packets Maxi Rockets (Fire Works) net weight 12 KG with proper seizure list I beg to submit that today on 03.11.21 at 13.15 hrs when I was engage in Day mobile duty vide C.C No-3916/21 dtd. 03.11.2021 then received information from my source that a huge number of fire crackers have been sold by above noted persons at their shop/house at Kantaranguni beside Bhloa Kali Mandir on Kashipur road under Adra PS. I informed the matter to you and as per your kind order myself along with C/122 Rabindra Kumar Verma, C/1119 Susanta Kumar Singha had been to the above noted place at 13.35 hrs. I parked the vehicle in a reasonable distance and cordoned the above noted shop by P.S. force. I detained 02 persons and on asked they disclosed their identity noted above and identified themselves as the owner of the above noted shop. I searched the shop of above noted Sk. Azad & Akbar Ali in presence of local disinterested witnesses and seized the above noted fire crackers from their shop with proper seizure list. I asked them to produce relevant documents regarding the said crackers but they failed to produce in favour of keeping, storing or selling of such combustibile or fire articles. On asked they also confessed his guilt regarding committing of offence. Accordingly, I arrested them observing all arresting guidelines.

It is noted here that Honble High Court Calcutta passed an order in WPA (P) 282 OF 2021 Dtd 29.10.21 regarding prohibition of selling of firecrackers and in this respect West Bengal Pollution Control Board passed an order vide Memo no 329 -21/WPB-F(V)/2021 Dated-30/10/21 for prohibiting the selling of fire crackers and its strict compliance.

Hence I pray before you to start a case in this respect under proper section of law and arrange its investigation.
