Sir,

In producing here with one arrested accused namely Sashiranjan Shaw (51 Yrs) S/O Lt. Umesh Shaw A/P-Kashipur C.S Shop, PS-Kashipur, Dist- Purulia, Permanent Adress-Vill-Arrah, PS-Nowada, Dist-Arrah (Bihar) along with following seized articles with seizure list and Memo of Arrest.

1) 26 bottles DIL KHUSH country spirit, 600 Ml. each Rs/-50 of each bottle.

I ASI Tanmoy Chatterjee of Adra PS do here by lodged a complaint against accused namely Sashiranjan Shaw (51 Yrs) S/O Lt. Umesh Shaw A/P-Kashipur C.S Shop, PS-Kashipur, Dist-Purulia, Permanent Adress-Vill-Arrah, PS-Nowada, Dist-Arrah (Bihar) to the effect that on 03/11/21 at about 18:05 hrs I received a telephonic information from a reliable source that one Sashiranjan Shaw has been transporting of country spirit illegally. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left for Adra PS vide Adra PS GDE No-105 dtd.03.11.2021. I along with force reached at Bilmoriya More Adra at about 19:05 hrs and I found one person walking towards Adra Town side from Kalikend village side and caring a plastic bag in his hand. On search I found that the said person caring 26 bottles of DIL KHUSH country spirit in a plastic bag for purpose of illegal transporting. I asked him to produced valid License or valid papers for the said country spirit but he failed to produce any valid license or documents for transporting /selling the same. So it is sufficient reason to believe that said Sashiranjan Shaw transporting the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 19.15 hrs to 19.45 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Sashiranjan Shaw (51 Yrs) S/O Lt. Umesh Shaw A/P-Kashipur C.S Shop, PS-Kashipur, Dist-Purulia, Permanent Adress-Vill-Arrah, PS-Nowada, Dist-Arrah (Bihar) under proper section of law.
