Sir,

In producing here with one arrested accused namely Rajkumar Sahu (43 Yrs) S/O Kesri Sahu of Vill-Murgu, PS-Sisai, Dist- Gumla, JKD, A/P-Vill-Bankradanga, PS-Adra, Dist-Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 20 bottles DIL KHUSH country spirit, 600 Ml. each Rs/-50 of each bottle.

I Si Satrughna Mahato of Adra PS do here by lodged a complaint against accused namely Rajkumar Sahu (43 Yrs) S/O Kesri Sahu of Vill-Murgu, PS-Sisai, Dist- Gumla, JKD A/P-Vill-Bankradanga, PS-Adra, Dist-Purulia to the effect that on today 26/11/21 in course of evening patrolling duty as per order vide Adra PS CC No-4121/21 dtd.26.11.21. I received a information from a reliable source at about 19:15 hrs that one Rajkumar Sahu is selling country spirit illegally at Kashipur Bus Stand. After getting such information I informed to I/C Adra P.s over telephone and as per his direction I along with accompanied force reached at Kashipur Bus Stand, Adra at about 19:25 hrs and held raid at Kashipur Bus Stand and found that the above noted accd. Person selling country spirit to the public at Kashipur Bus Stand and after seeing the Police party, all the person fled away and said Rajkumar Sahu has tried to concealed himself but we able to apprehend him. I asked him to produced valid License or valid papers in respect of selling of country spirit but he failed to produce any valid license or documents in respect possessing /selling the same. So it is sufficient reason to believe that above said Rajkumar Sahu engaged to sale the country spirit by illegal way. So I seized the above mentioned country spirit under proper seizure list duly sign by accused person and available witnesses. I also collect sample from seized country spirit duly sealed and labeled by me. There after I arrest the above mentioned accused person with informing him the ground of arrest. The complete process was done in between 19.25 hrs to 19.45 hrs.

I there for pray that a specific case may kindly be start against arrested accused Rajkumar Sahu (43 Yrs) S/O Kesri Sahu of Vill-Murgu, PS-Sisai, Dist- Gumla, JKD A/P-Vill-Bankradanga, PS-Adra, Dist-Purulia under proper section of law.
