Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Bhagaban Mahato (40 Yrs) S/o- Lt. Karmu Mahato of Vill- Sindri, PS- Purulia (M), Dist- Purulia, along with Memo of arrest, seizure list & seized articles 18 (Eighteen) packets of Rolex Chocolate (Royal Quality)bomb and 07 (Seven) packet of two sound bomb (One Dozen per packet)approx 2kg, I beg to submit that on 03.11.2021 as per source information & direction of O/C Arsha PS; myself along with force had been to Dhanara More (Bus Stand) to work out the information regarding selling of fire crackers.

Accordingly, myself along with force namely C/- 238 Dipak Bagti & C/- 970 Kartik Jana with Govt. vehicle reached at Dhanara More Near Bus Stand at 10:35 hrs and found that one person is selling and dealing with fire crackers (Prohibited articles) and seen the Police party tried to fled away. Somehow we managed to apprehend him and on being asked his identity, he disclosed his identity as Bhagaban Mahato (40 Yrs) S/o- Lt. Karmu Mahato of Vill- Sindri, PS- Purulia (M), Dist- Purulia. I asked him to produce valid paper/license in respect of selling/ keeping/dealing with fire crackers (prohibited articles). He failed to produce any papers or license and cannot gives any satisfactory answer and confesses his guilt.
