Sir,

I, SI Subal Goswami of Arsha PS do hereby lodge this written complaint to the effect that today (27.11.21) at about 09.05. hrs I received source information that some villagers put up a road blockade at village Boram under PS- Arsha on Arsha-Kotshila Pucca road. This refers to Arsha PS GDE No. 985 Dt. 27.11.21. Accordingly as per direction of O/C, Arsha PS, myself accompanied by available force vide Spl. CC No. 134/21 Dt. 27.11.21, left for the place to work out the information. We arrived at village Boram at 09.25 hrs and found 15/16 persons blocked the pucca road and were standing on the road, causing total stoppage of vehicular movement. About 15/20 four wheeler and about 40 (forty) Motor cycles were stranded owing to the blockade. The act of the persons caused obstruction to general public. After pursuance, we managed to remove the blockade after at least 45 minutes. After a brief enquiry, it came to light that the blockade was conducted by 1. Donaram Mahato S/O Lt. Aklu Mahato 2. Baneswar Mahato 3. Maheswar @ Lodhai Mahato both S/O Donaram Mahato 4. Sanjoy Mahato S/O Lt. Bhaju Mahato 5. Birinchi Mahato S/O Lt. Baroni Mahato all of village Boram, PS- Arsha, Dist-Purulia and 12/13 others over a land dispute.

In the circumstance I pray that a case under proper section of law may kindly be initiated against the accused.
