Sir,

In producing herewith the accused person namely Bharat Sing Mura (33 Yrs), S/O- Lt. Pahar Sing Mura of Vill- Gosaidih, PS-Baghmundi, Dist- Purulia along with seized articles 1) 09 (Nine) liter ID Liquor containing in a white plastic jerican, 2) 07 (Seven) Pcs Plastic Glasses which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 26.11.2021 during my mobile duty as per source information I along with force 1. C/783 Md. Rezaul Karim, 2. C/733 Md. Haidar Ali both of SAP 11th Bn. Camp at Baghmundi P.S, Dist-Purulia reached at Gosaidih village at 17:15 hrs and found that the above noted person is selling I.D liquor at his house premises under Baghmundi P.S, Dist Purulia. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. I seized 1) 09 (Nine) liter ID Liquor containing in a white plastic jerican, 2) 07 (Seven) Pcs Plastic Glasses from his possession U/S- 67 B.E. Act which were seized under proper seizure list duly signed by the witnesses. All seized articles were labeled properly in presences of witness and accused person. Hence I arrested the above noted person at 17:55 hrs. after maintaining all formalities and guidelines regarding arrest. I offered him medical treatment but he refused.

The above noted arrested accused person namely Bharat Sing Mura (33 Yrs), S/O- Lt. Pahar Sing Mura of Vill- Gosaidih, PS-Baghmundi, Dist- Purulia committed an offence U/S- 46 A (c) B.E. Act 1909 for unauthorized possession and selling of ID Liquor from his sole possession.

Under the fact and circumstances I therefore pray before you a specific Case may kindly be started against the said accused person under proper section of law and arrange its investigation.
