Sub: Prayer for lodging FIR

Sir,

I, S.I Susanta Kr. Pathak of Balarampur P.S. brought under seizure of the following articles as per seizure list and lodge this complaint against accd. person Binod Barnawal (50 yrs) S/O- Lt. Sitaram Prasad Barnwal of Vill- Balarampur Barabazar road (near Balarampur Bus stand), P.S- Balarampur, Dist-Purulia and I also beg to report that on 03.11.2021, I along with C/2301 Barun Mandal, C/2583 Chinmoy Patihar of Balarampur P.S in course of evening mobile duty vide Balarampur P.S. C.C. No. 3283/21 dt. 03.11.2021 and G.D. Entry No. 113 dt. 03.11.2021 received source information that the aforesaid accd. person is selling Fire crackers and combustible articles in his shop situated at Balarampur Barabazar road (near Balarampur Bus stand), Balarampur P.S without any authorization of license from appropriate authority in a negligent manner which is hazardous and endanger for human lives. After observing all informative action to my superiors, I along with force left for Balarampur Barabazar road (near Balarampur Bus stand) under Balarampur P.S. to work out the information.

Today (03.11.2021) at 19:05 hrs, we arrived Balarampur Barabazar road (near Balarampur Bus stand) under Balarampur P.S. and in presence of witnesses searched the shop owned by Binod Barnawal (50 yrs) S/O- Lt. Sitaram Prasad Barnwal of Vill- Balarampur Barabazar road (near Balarampur Bus stand), P.S- Balarampur, Dist-Purulia on 03.11.2021 between 19:10 hrs. & 19:35 hrs. in course of conducting search found 1) 24 packets ( 04 bundles X 06 packets) SACHIN Senior Chocolate Fire Cracker. 2) 48 packets (08 bundles X 06 packets) DIL Chocolate Fire Cracker, 3) 36 packets (06 bundles X 06 packets) BISHAL Chocolate Fire Cracker approx weight 05 kgs, in the shop style as "Binod Verity Store". On demand the shop owner Binod Barnawal could not be able to give any satisfactory answer for keeping & selling such fire crackers and combustibles articles, though the Hon'ble High Court, Calcutta banned use or display or busting of fire crackers and also sell or purchase of fire crackers in any form in the state in all during coming festival season vide order dtd. 29.10.2021 in C/W WPA(P) 282 of 2021 along with CAN 1 of 2021 and CAN 2 of 2021. On being enquiry the shop owner Binod Barnawal is dealing such business from his Stationary shop style as "Binod Verity Store" without any valid license of the competent authority. Hence, in presence of witnesses I seized the above noted fire crackers and combustibles articles from the shop under proper seizure list duly signed by the witnesses and the shop owner Binod Barnawal. As the above noted person was selling fire crackers and combustibles articles without valid license and violated the Order of Hon'ble High Court, Calcutta. So, I arrested the shop owner Binod Barnawal (50 yrs) S/O- Lt. Sitaram Prasad Barnwal of Vill- Balarampur Barabazar road (near Balarampur Bus stand), P.S- Balarampur, Dist-Purulia after observing all legal formalities.

Therefore, I pray a case may kindly be initiated against arrested Binod Barnawal (50 yrs) S/O- Lt. Sitaram Prasad Barnwal of Vill- Balarampur Barabazar road (near Balarampur Bus stand), P.S-Balarampur, Dist-Purulia with proper section of law and arrange for its investigation.
