

1. That the complainant is the permanent resident of village Tentlo within p.s. Balarampur and within the jurisdiction of this Court.
  
2. That the complainant has got some landed properties in mouza Tentlo bearing R.S. plot no. 1731 area 139 dec.
  
3. That the accused persons has got their eye in the property of the complainant and off and on the accused persons gave out threat to the complainant by using ~~in~~ fulthy language and pressuring him to execute a sale deed in respect of the property bearing R.S. plot no.1731.
  
4. That the complainant submit th that complainant being a Rickshaw puller and a poor man the accused person are taking the advantage of the same, they on 10.9.2021 assaulted the complainant with fist and blowing and threatening him to execute a deed in this favour and accordingly the complainant had been to the local p.s. and lodge an F.I.R. against the accused persons but the O.C. Balarampur p.s. did not take any steps against the accused persons.
  
5. That thereafter the complainant also submit an application before superintendent of police u/s 156(3) Cr.P.C. on 28.9.2021 stating the fact and offence committed by the accused persons. .
