Sub: Prayer for starting a specific case against arrested accused namely Sadhan Mandal (age- 35 yrs) S/O-Lt. Dhubaraj Mandal of Vill-Kuilapal, PS-Bandwan, Dist-Purulia.

Sir,

In producing herewith arrested accd Sadhan Mandal (age- 35 yrs) S/O-Lt. Dhubaraj Mandal of Vill-Kuilapal, PS-Bandwan, Dist-Purulia with arrest Memo, along with seized articles i.e. (1) 42 packets Rolex Royal Quality Chocolate firecrackers, Gross weight=04 kg 450 gm (approx) (2) 10 packets Rolex Super Chocolate firecrackers, Gross weight=01 kg 900 gm (approx) (3) 150 packets King Cobra Electric firecrackers, Gross weight=05 kg 940 gm (approx) (4) 12 packets Burimar's big Chocolate firecrackers, Gross weight=520 gm (approx) (5) 12 packets Bobby Chocolate firecrackers, Gross weight =540 gm (approx) (6) 07 packets Tohfan Chocolate firecrackers, Gross weight=360 gm (approx) (7) 06 packets JUGMUG junior Chocolate firecrackers, Gross weight=290 gm (approx), Total firecrackers =239 packets and Total weight=14 kg (approx) under proper seizure list, I beg to report that, on 03/11/21 during my day mobile duty received a telephonic information from my source that one person is selling firecrackers illegally in his shop. Accordingly, I informed the matter to O/C Bandwan PS and as per his direction myself along with C/03 Nityalal Hansda, C/174 Somnath Tudu started for working out the information vide Bandwan PS C.C. No 3024/21 dated- 03.11.2021 and briefing them carefully about the information and my plan to catch him red handed. We reached at Kuilapal bazar on 03.11.21 at 11:15 hrs. and proceeded to the spot on feet and as per public information identified the shop. We entered into the shop and seeing police personnel 2/3 persons fled away from the shop and we detained one person who on asked revealed himself as Sadhan Mandal S/O-Lt. Dhubaraj Mandal of Vill-Kuilapal, PS-Bandwan, Dist-Purulia and identified himself as the owner of the shop and when I told him about the information, he fully confessed that he used to sell crackers and on searching the shop recovered (1) 42 packets Rolex Royal Quality Chocolate firecrackers, Gross weight=04 kg 450 gm (approx) (2) 10 packets Rolex Super Chocolate firecrackers, Gross weight=01 kg 900 gm (approx) (3) 150 packets King Cobra Electric firecrackers, Gross weight=05 kg 940 gm (approx) (4) 12 packets Burimar's big Chocolate firecrackers, Gross weight=520 gm (approx) (5) 12 packets Bobby Chocolate firecrackers, Gross weight =540 gm (approx) (6) 07 packets Tohfan Chocolate firecrackers, Gross weight=360 gm (approx) (7) 06 packets JUGMUG junior Chocolate firecrackers, Gross weight=290 gm (approx), Total firecrackers =239 packets and Total weight=14 kg (approx). On being demanded he failed to produced any license or constitutional papers in favour of keeping, storing or selling any firecrackers or combustible or fire articles and also confessed that inspite of knowing it fully well that it is strictly illegal and unlawful to sell, keep or store, he had been selling those firecrackers after having a huge store of it in the shop from the past few days. Accordingly, I seized the above mentioned firecrackers from his exclusive possession after furnishing proper seizure list and arrested him accordingly for his negligent conduct with respect to fire or combustible or explosive substances which can be endangered to human life. I would like to note here that though the punishment of the offence he has committed is less than 07 years yet I arrested him because he may tamper the evidences.

I would like to bring your kind attention that presently as per order of West Bengal Pollution Control Board vide Memo No. 329-2L/WPB-F(V)/2021 bursting of any kind firecrackers has been prohibited.

Hence, I pray that a specific case may kindly be started against above noted arrested accused person under proper section of law and arrange for its investigation.
