Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Gadadhar Singh Modak (66 Yrs) S/o- Anadi Singh Modak of Vill- Barabazar Nilmohanpur, PS- Barabazar, Dist- Purulia, along with Memo of arrest, seizure list & seized articles i.e i) Fire Crackers (Bijli) , Muri Patka-95 Packets, each contains 100 pieces ii) Fire Crackers (Choklet bomb- Superman)-18 Pieces iii) Fire Crackers, Rokat bomb (Fireworks)-50 pieces iv) Fire Cracker, Roll cap-20 Pieces V) Aston Villa, Fire Cracker (Fire Work) 01 Packet, Flammable Explosive vi) Fire Cracker, flower pots Giants (Flammable)- 10 Packet each contains 10 Pieces Vii) Fire Cracker, Ben 10 (Kitkat) (Fire woroks)-20 Pieces Viii) Fire Cracker, Alu bomb-20 Pieces. I beg to submit that on 03.11.2021 as per source information & direction of I.C Barabazar PS; myself along with force had been to Barabazar Nilmohanpur to work out the information regarding selling of fire crackers.

Accordingly, myself along with force namely C/- 347 Manas Pathak & C/- 1182 Santosh Kr. Mahato with Govt. vehicle bearing registration No- WB 26K 5475 reached at Barabazar Nilmohanpur at 10.45 hrs and found that one person is selling and dealing with fire crackers (Prohibited articles) from his Goomty shop situated at Barabazar Nilmohanpur more and seeing the Police party the shop keeper & buyers tried to fled away. Somehow we managed to apprehend the shop keeper but others fled away and on being asked he disclosed his identity as Gadadhar Singh Modak (66 Yrs) S/o- Anadi Singh Modak of Vill- Barabazar Nilmohanpur, PS- Barabazar, Dist- Purulia. I asked him to produce valid paper/license in respect of selling/ keeping/dealing with fire crackers (prohibited articles) and as Hon'ble High Court, Calcutta regarding prohibition of sound firecrackers and guide line of Govt. of West Bengal regarding pandemic "COVID-19" is going on. He failed to produce any papers or license and cannot gives any satisfactory answer and confesses his guilt. The above noted owner of the shop did not use 'face mask' & follow other directions regarding "COVID-19"

Accordingly, I seized i) Fire Crackers (Bijli) , Muri Patka-95 Packets, each contains 100 pieces ii) Fire Crackers (Choklet bomb- Superman)-18 Pieces iii) Fire Crackers, Rokat bomb (Fireworks)-50 pieces iv) Fire Cracker Roll cap-20 Pieces V) Aston Villa, Fire Cracker (Fire Work) 01 Packet, Flammable Explosive vi) Fire Cracker, flower pots Giants (Flammable)- 10 Packet each contains 10 Pieces Vii) Fire Cracker, Ben 10 (Kitkat) (Fire woroks)- 20 Pieces Viii) Fire Cracker, Alu bomb-20 Pieces. I marked the Alamat as Exhibit- A; from the possession of the above noted accused person. The seizure list was prepared at P.O and duly signed by detained persons and witnesses. After that I arrested him by issuing memo of arrest. Then myself along with force, seized articles and all relevant papers and accused persons left for PS.

On arrival at PS I prepared this letter of complaint and handed over everything to I.C Barabazar through Duty officer for starting a case under proper section of law against the accused persons
