Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused person namely Bidyapati Singh Modak (42 Yrs) S/o- Lt. Shaktipada Singh Modak of Vill- Barabazar Nilmohanpur, PS- Barabazar, Dist- Purulia, along with Memo of arrest, seizure list & seized articles i.e i) Fire Cracker, Alu bomb-30 Pieces ii) Fire Crackers (Choklet bomb- Shaktiman)-12 Pieces iii) Fire Cracker (Tik Tok)- 3 Pieces manufactured by Sri Thangavel Chakravarty Fire Works Industries, Sivakasi iv) Fire Cracker styled as AVTAR 50- 01 Pkt. manufactured by Sonny Fire works (P) LTD. V) Fire Cracker Sunrise 28 Deluxe 1 packet contains 28 pieces vi) Fire Cracker (SUTLI BOMB)- 3 Pieces vii) 01 (one) old bi-cycle & Viii) 01 (one) white colour plastic bag. I beg to submit that on 03.11.2021 as per direction of I.C Barabazar PS; myself along with C/- 1211 Chunaram Hembram & C/- 1474 Tushar Kanti Mandal had been to Bamnidih Interstate NAKA Checking point by Govt. Vehicle for NAKA Checking against illegal/band fire crackers.

During Naka Checking at 12.45 hrs. we found 01 (one) person coming from Katin side with bi-cycle with one bag towards our Naka Checking point. Seeing the Police party he tried to fled away but after chase we managed to apprehend him. During search we found above noted firecrackers inside his bag. On being asked he disclosed his identity as Bidyapati Singh Modak (42 Yrs) S/o- Lt. Shaktipada Singh Modak of Vill- Barabazar Nilmohanpur, PS- Barabazar, Dist- Purulia. I asked him to produce valid paper/license in respect of keeping/carrying with fire crackers (prohibited articles) and as Hon'ble High Court, Calcutta regarding prohibition of sound firecrackers and guide line of Govt. of West Bengal regarding pandemic "COVID-19" is going on. He failed to produce any papers or license and cannot gives any satisfactory answer and confesses his guilt. The above noted owner of the shop did not use 'face mask' & follow other directions regarding "COVID-19"

Accordingly, I seized i) Fire Cracker, Alu bomb-30 Pieces ii) Fire Crackers (Choklet bomb- Shaktiman)-12 Pieces iii) Fire Cracker (Tik Tok)- 3 Pieces manufactured by Sri Thangavel Chakravarty Fire Works Industries, Sivakasi iv) Fire Cracker styled as AVTAR 50- 01 Pkt. manufactured by Sonny Fire works (P) LTD. V) Fire Cracker Sunrise 28 Deluxe 1 packet contains 28 pieces vi) Fire Cracker (SUTLI BOMB)- 3 Pieces vii) 01 (one) old bi-cycle & Viii) 01 (one) white colour plastic bag. I marked the Alamat as Exhibit- A; from the possession of the above noted accused person. The seizure list was prepared at P.O and duly signed by detained persons and witnesses. After that I arrested him by issuing memo of arrest. Then myself along with force, seized articles and all relevant papers and accused persons left for PS.

On arrival at PS I prepared this letter of complaint and handed over everything to I.C Barabazar through Duty officer for starting a case under proper section of law against the accused persons
