With due respect I beg to state that one mass petition regarding damage statue of BABA TILKA MAJHI (MURMU) was received at Barabazar PS vide Part- IV No- 212/2021 Dtd. 06.11.2021. As per endorsement I enquired the matte petition locally.

I noted my enquiry matter has been noted vide Barabazar PS GDE No- 278 & 291 Dtd. 06.11.2021, GDE No- 323 & 332 Dtd. 07.11.2021, GDE No- 395 & 408 Dtd. 08.11.2021 and GDE No- 498 & 502 Dtd. 10.11.2021. It came to light that a statue of "BABA TILKA MAJHI (MURMU)" freedom fighter situated at Herbona morh under Barabazar PS. Dist-Purulia since long time before.

On 05.11.2021 morning local people found that the bow of said statue has been grounded on the stage of the statue as broken condition. On being asked it came to light that the incident was happened on the night of 04/05.11.2021 and they strongly believed that some unknown miscreants did such notorious act of commit mischief upon the statue.

Myself engaged a reliable source with intent to unearthed the truth of the incident.

The grounded bow was the prove of the fact. It was made of bamboo. The said bow was in the clutch of the left hand of the said statue and tightened by concrete cement.

So, beyond any doubt the incident happened by an unknown miscreant with intent to create nuisance and L/O problem in that locality.

Under the above fact and circumstance I pray before your kind self that necessary lawful action may kindly be taken from your end.
