Sub: Complaint against Anil Majhi (36 Yrs) S/o- Goti Majhi of Vill- Porsa, PO- Bhabanipur, PS-Barabazar, Dist- Purulia to start a specific case under proper section of Law.

Sir,

In producing here with arrested accused person namely Anil Majhi (36 Yrs) S/o- Goti Majhi of Vill- Porsa, PO- Bhabanipur, PS- Barabazar, Dist- Purulia and seized 17 (Seventeen) Plastic Bottle of Country Spirit (DIL KHUSH) containing 600 M.L in each Bottle, in which 01 Bottle taken as sample as per enclosed seizure list.

I, ASI Sadhan Ch. Danda of Barabazar PS do here by lodge this complaint against Anil Majhi (36 Yrs) S/o- Goti Majhi of Vill- Porsa, PO- Bhabanipur, PS- Barabazar, Dist- Purulia. I beg to state that on 26.11.2021 at about 18.25 hrs during my evening mobile duty I received telephonic information that one person was selling liquor in his house at Porsa village. I was there to verify the credibility of that information and immediately informed the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with C/- 975 Ashoke Saharay & C/-1474 Tushar Kanti Mandal had been to the said place by Govt. vehicle to work out the information. At about 19.15 hrs I detained one person at Porsa village under Tumrasole G.P who was selling liquor in his house. Seeing the Police party the alleged person and customers were tried to flee away, but I apprehended the seller with the help of the Police party and on being searched I found that the person stocking 17 (Seventeen) Plastic Bottle of Country Spirit (DIL KHUSH) containing 600 M.L in each Bottle for selling. On demand, he failed to produce any valid documents / License in respect of stocking or selling of Country Spirit. On being asked he confessed his guilt and stated that he was stocking the Country Spirit with intent to sell to make his own profit. He disclosed his identity as Anil Majhi (36 Yrs) S/o- Goti Majhi of Vill- Porsa, PO- Bhabanipur, PS- Barabazar, Dist- Purulia. He also admitted that he has no license or any authorization for stocking & selling Country Spirit. Accordingly, I seized 17 (Seventeen) Plastic Bottle of Country Spirit (DIL KHUSH) containing 600 M.L in each Bottle after preparing proper seizure list and put label on the seized articles in presence of witnesses in which 01 (One) Bottle taken as sample which were also duly labeled by me and also took signature of the accompanying witness as well as accused person also on the Seizer list and label. The seizure and label was done in between 19.35 hrs and 19.55 hrs.

Thereafter, I secured arrest the accused person namely Anil Majhi (36 Yrs) S/o- Goti Majhi of Vill- Porsa, PO- Bhabanipur, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. I informed him regarding the ground of arrest and his relatives regarding arrest. The arrest was made on 26.11.2021 at 20.05 hrs.

After returned to PS, I prepared this complaint and submitted before I.C Barabazar PS through Duty officer ASI Dinabandhu Bauri to start a specific case against the arrested accused person namely Anil Majhi (36 Yrs) S/o- Goti Majhi of Vill- Porsa, PO- Bhabanipur, PS-Barabazar, Dist- Purulia under proper section of Law.
