Sir,

I, SI Uttam Chatterjee of Barabazar PS Dist Purulia do here by submit a written complaint against unknown vehicle to the effect that on 09/11/2021 at 19.35 to 20.00 hrs. 04 (Four) persons were returning their home by their bi-cycle from Barabazar at that time an incident took place on Barabazar-Katin pitch road near Kishanmandi under Barabazar PS. As a result they were sustained serious injuries and shifted to Barabazar BPHC and on duty MO declared Dipali Majhi (4 Yrs) as brought dead and 03 (Three) others shifted to higher centre for batter treatment. I also prepared surat hal report upon the dead body of deceased Dipali Majhi and sent the dead body before Autopsy surgeon Deben Mahato Sadar Hospital Purulia for holding PM examination to ascertain the actual cause of death. During enquiry I seized one damaged "Atlas" Company bicycle as well as wearing apparels of the deceased.

During enquiry no body submitted any complaint over this incident. Today on 27/11/2021 received PM examination report of the deceased namely Dipali Majhi (4 Yrs) D/o- Badal Majhi of Vill- Parkidih, PS- Barabazar, Dist- Purulia vide PM No-962/2021 dt 10/11/2021 prepared by Dr Baishakhi Koley Demonster/Tutor Department of FMT Purulia Govt Medical College & Hospital and on perusal found that cause of death **-Death was due to the effects of ante mortem injuries.** I also noted here that from the enquiry it is clear that Dipali Majhi was returning home with her family members by their bi-cycle on 09/11/2021 at about 19.35 to 20.00 hrs From Barabazar at that time took an incident by themselves. As a result they were sustained injuries shifted to Barabazar BPHC and on duty MO declared Dipali Majhi (4 Yrs) as brought dead and 03 (Three) others shifted to higher centre for batter treatment.

Under the above facts I am submitting a written complaint against the driver for rush & negligent driving for taking lawful action.
