In inviting a reference as mentioned in the above subject matter, the undersigned would like to state on 28/11/2021 at about 7.50 a.m. a joint raid has been carried out in different places under the jurisdiction of the undersigned in presence of the Additional District Magistrate and District Land & Land Reforms Officer, Sub-Divisional Officer, DMDC, Manbazar, ADFO, Block Development Officer, Barabazar, Forest Ranger, Barabazar Range, IC Barabazar and other Officials and during such operation it is found that in plot no 3 of mouza Gohomikocha an illegal excavation of black stone is being carried out by some miscreants. Though at the time of the said operation nobody was found engaged in such illegal excavation of black stone. It is also found during such visit that the entire area of the said plot is being used for such illegal excavation of stone. From the official record of the undersigned it is found that the entire plot is recorded in the name of Forest Department, Government of West Bengal.


