On being asked the following persons could not able to give any satisfactory answer for that not wearing Mask in this pandemic situation. As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and brought them to PS.

1. Chutulal Mahato (28) S/O- Lt. Tanu Mahato of Vill- Jambedia, PS Boro, Dist.- Purulia.
2. Jayanta Paul (28) S/O- Lt. Paban Paul of Vill- Baghabaid, PS- Boro, Dist- Purulia.
3. Furgal Mandi (29) S/O- Bipin Mandi of Vill- Rayna, PS- Boro, Dist- Purulia.
4. Arjun Kr. Mahato (36) S/O- Jitendranath Mahato of Vill- Jorobari, PS Boro, Dist- Purulia.
5. Sahebram Majhi (45) S/O- Bhadari Majhi of Vill- Surigora, Tola Rajagram PS- Manbazar, Dist- Purulia.
