With due respect I beg to submit before you that on 12.11.2021 at about 15.05 hrs while I, SI Dipak Kr. Nandi along with force were engaged on area round duty in P.S. area and found the following persons were moving at Dangardih more under Boro PS without wearing Mask, as such I detained them on that spot. On being asked the following persons could not able to give any satisfactory answer for that not wearing Mask in this pandemic situation. As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and brought them to PS.

1. Samir Mahato (48) S/O- Banamali Mahato of Vill- Dangardih, PS Boro, Dist.- Purulia.
2. Amulya Mandi (27) S/O- Girish Ch. Mandi of Vill- Dangardih, PS- Boro, Dist- Purulia.
3. Seven Saren (27) S/O- Manindra saren of Vill- Ajodhyadih, PS- Barabazar, Dist- Purulia.
4. Partha Mahato (20) S/O- Chittaranjan Mahato of Vill- Jorobari, PS - Boro, Dist- Purulia.
5. Tapas Karmakar (32) S/O- Bijoy Karmakar of Vill- Serengdih, PS - Boro, Dist- Purulia.
