Respected Sir,

In producing herewith 01 (one) arrested accused namely Bulu Banerjee (age- 48 yrs) S/O-Lt. Nimai Ch. Banerjee of Vill- Ladhurka, PS-Hura, Dist-Purulia along with seized articles (1) 09 (Nine) packets of fire crackers containing 10 Pcs each, styled as 'BLACK CAT', (2) 15 (Fifteen') packets fire Crackers containing 12 Pcs each, styled as 'DULAL' (3) 03 (Three) packets of fire crackers containing 10 Pcs each, styled as 'BULLET', with proper seizure list I beg to submit that today on 03.11.21 at 18.05 hrs during spl mobile duty at PS area vide Hura PS GDE No-98 Dtd-03.11.2021 and Spl CC No-172 Dtd-03.11.2021 received an information from my source that a huge number of fire crackers have been sold by above noted person at his shop at Ladhurka under this PS and informed the matter to before you and as per your kind order had been to the above noted place with C/660-Arup Nath, JC/1460-Md Amir-at 18.15 hrs. I parked the vehicle in a reasonable distance and cordoned the above noted shop by P.S. force. I detained 01 person and on being asked he disclosed his identity noted above and identified himself as the owner of the above noted shop. I searched the shop of above noted Bulu Banerjee in presence of local disinterested witnesses and found the above noted articles and I asked him to produce relevant documents regarding the said crackers but he failed to produce in favour of keeping, storing or selling of such combustible or fire articles. On being asked he also confessed his guilt regarding committing of offence Then I seized the above noted fire crackers from his shop with proper seizure list in between 18.25 hrs and 18.55 hrs. Accordingly, I arrested him after observing all arresting guidelines as he committed offence under section-188 /285/286 IPC & 24/26 of the WBFS Act 1950.

It is noted here that Honb'le High Court Calcutta passed an order in WPA (P) 282 OF 2021 Dtd 29.10.21 regarding prohibition of selling of firecrackers and in this respect West Bengal Pollution Control Board passed an order vide Memo no 329 -21/WPB-F(V)/2021 Dated-30/10/21 for prohibiting the selling of fire crackers and its strict compliance.

Hence I pray before you to start a specific case in this respect under section-188 /285/286 IPC & 24/26 of the WBFS Act 1950.
