Finding no other alternative I arrested him after observing all legal formalities and seized and labeled 1. 15 (Fifteen) sealed bottle of DIL SE (Country Spirit) containing each 600 ml 2. 06 No of empty bottle of DIL SE 3. 07 no of plastic glasses 4. RS 105/- as sale proceed which was seized under proper seizure list duly singed by the witnesses and also arrested him at 17:05 hrs. after followed all formalities.

The above noted arrested accd. namely Mitan Kalindi (40 yrs) S/O- Lt. Naru Kalindi of Vill- Bishpuria(Majhdih), PS- Hura, Dist- Purulia has committed offence u/s 46 A(c) B.E.Act. 1909 for unauthorized possession and sale of country spirit.

Under the fact and circumstances I pray before you that a case u/s 46 A (c) B.E.Act. 1909 may kindly be started against Mitan Kalindi (40 yrs) S/O- Lt. Naru Kalindi of Vill- Bishpuria(Majhdih), PS- Hura, Dist- Purulia, and arrange for its investigation.
