Sir,

In producing here with arrested accused namely Madhu Mudi (50 Yrs) S/O- Lt. Suku Mudi of Vill- Bagdisha, PS- Hura, Dist- Purulia along with seized one white colour plastic container containing approx 10(ten) ltrs. ID liquor (details of seized articles are mentioned in attached seizure list), I beg to submit that today i.e. on 26.11.2021 while I SI Bablu Ghosh along with C/660 Arup Nath, C/1370 Satyendra Prasad Sing and NVF/908 Lakhindar Sing Mura were performing special evening mobile at Ladhurka side vide Hura PS C.C. No.-3195/21 date- 26.11.21 and at about 19:05 hrs. received a credible source information from my reliable source that the above noted accd. person was stoking and selling Id liquor in his house at Bagdisha village. Accordingly I informed the matter to O/C Hura PS and as per his direction I SI Babnlu Ghosh along with force left for work out that information. After reaching to spot along with force at about 19:35 hrs. and held raid in between (19:40 hrs. to 20:25 hrs) in the house of above noted accused person at Bagdisha under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling ID liquor which was kept in his house at Bagdisha under Hura PS, Dist Purulia. On demand, he failed to produce any valid documents/ License in respect of selling and stocking ID liquor. Accordingly, I seized one white colour plastic container containing approx 10 (ten) ltrs. ID liquor after preparing proper seizure list duly signed by the witnesses and labeled sample one bottle approx 600 ML. Then I arrested him U/S- 67 B.E. act. after preparing proper Arrest Memo, maintained all formalities regarding arrest as he committed offence U/S 46A(c) B.E. Act and supplied one copy to him. This is to note here that on seeing police party all public/customers left the place.

Under the above fact circumstances and, I therefore pray that a Cog. Case U/S 46A(c) B.E Act may kindly be started against the arrested accused person Madhu Mudi (50 Yrs) S/O- Lt. Suku Mudi of Vill- Bagdisha, PS- Hura, Dist- Purulia and arrange for its investigation.
