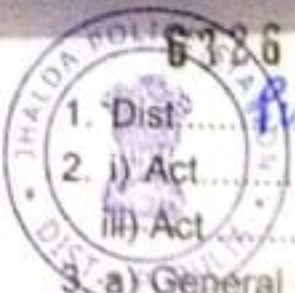

Sub: Prayer for starting a specific case.



Producing here with one arrested accused person namely Kailash Kalindi (39 yrs) S/O Lt. Metra Kalindi of Vill- Bandhaghat, PS-Jhalda, Dist- Purulia along with seized articles (i) One white colour vehicle (Bolero Pickup) having Reg. No- JH 01EF/8613 loaded with SL-2 & 3 articles (ii) 54 cartoons containing 100 packet Kamla Pasand pan masala in each cartoons, where as in each packets contains 33 unites Pan Masala (iii) 10 sacks containing 100 packets Double Black Tobacco in each sacks, where as in each packets contain 34 unit Double Black Royal touch chewing Tobacco (iv) One packet Kamla Pasand Panmasala and One packet of Double Black Royal touch chewing Tobacco for sample before you.

The fact of the case in a nutshell is that today (08.11.2021) I, SI- Prasanta Sau along with force namely i) C/38- Parbati Mudi ii) C/1484 Kajal Kr. Nayek iii) NVF/39-Lalit Kishor Mahato iv) NVF/843-Bibek Mahato all of Jhalda PS were performing evening mobile duty in PS area vide Jhalda P.S. GDE No- 302 Dated- 08/11/2021 in consonance with Jhalda PS CC No- 4470/21 Dated- 08/11/2021. During my evening mobile duty I received credible source information that One white colour vehicle (Bolero Pickup) having Reg. No- JH 01EF/8613 was coming from Ranchi side containing with Tobacco ingredients materials to sale in Jhalda town, Kotshila, Joypur area. Subsequently, I informed you and as per your gracious order, I placed Naka at Birsha more to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the one vehicle (Bolero Pickup) was coming towards Jhalda town. Consequently, we intercepted the said vehicle (Bolero Pickup) at Birsha more at about 20:15 hrs and found that the vehicle as well as goods as identical as I received prior information. Thereafter I asked the driver of the vehicle to show the valid documents in respect of the vehicle as well as the goods but the driver noted in the above was failed to produce any valid documents in respect of the vehicle and the goods. After a prolonged interrogation the driver confessed one Srikant Barui of Jhalda Main road asked him to sell these goods in Jhalda town area and other parts in Purulia District. Though, driver of the vehicle stated incoherent statement in different times. It was ascertained that the driver of the vehicle in cahoots with the owner of the vehicle and others by illegal means for selling these prohibited goods containing tobacco ingredients to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that he in cahoots with the owner of the vehicle and others procured these goods by fraudulently means or theft or by any means for transporting the same to run clandestine business. Ergo I, seized (i) One white colour vehicle (Bolero Pickup) having Reg. No- JH 01EF/8613 loaded with SL-2 & 3 articles (ii) 54 cartoons containing 100 packet Kamla Pasand pan masala in each cartoons, where as in each packets contains 33 unites Pan Masala (iii) 10 sacks containing 100 packets Double Black Tobacco in each sacks, where as in each packets contain 34 unit Double Black Royal touch chewing Tobacco (iv) One packet Kamla Pasand Panmasala and One packet of Double Black Royal touch chewing Tobacco for sample under proper seizure list in presence of available witnesses duly signed by them. Thereafter, I brought the same to Jhalda PS compound.

It is pertinent to say that the Commissioner of Food Safety West Bengal prohibited the manufacture, storage, sale or distribution of gutkha and pan masala containing tobacco or nicotine as ingredients by whatsoever name it is available in the market for the period of one year with effect from 07th day of November 2021 in the state of West Bengal in the interest of public health vide notification No- 355/HA/CFS/1M-6/2012 (Pt-II) dated-Kolkata, the 20/10/2021 in pursuance of regulation 2.3.4 of the Food Safety and standards (Prohibition and Restrictions on sales) Regulations 2011. As such the driver noted above and the owner and others violated the supra order, so they are liable to be punished under Food Safety and standards Act 2006.

Under the above facts and circumstances kindly take lawful action against the driver of the said vehicles and one Srikant Barui and others who are involved in this case as they committed offence U/S 379/411/414/188/120B of the IPC & 59 of Food Safety and standards Act 2006.
