

Respected Sir.

In producing herewith one arrested aced namely Barun Kuiry (43 yrs) S/O Biswanath Kuiry of Vill-Mohanpur, Kotshila PS, Dist- Purulia with Memo of Arrest, Inspection Memo and seized articles viz. i) one Iron Made improvised pipe gun length approx 10.5 inch in which the length of barrel with body approx 7.3 inch and length of butt approx 3.2 inch in which the firing pin is present, ii) One live 8 mm. ammunition in which one slide spot of Trigger pin is present and it was loaded in Sl. No-1 under proper seizure list. I, S.I Asoke Kr. Sen beg to inform you that today (10/11/21) at 19:45 hrs during my evening mobile duty (vide Jhalda PS CC No-4492 and Jhalda PS GDE No-388 dated-10/11/21) received an information from my reliable source that one person aged about 40/42 yrs was seen loitering at back side of Jhalda Railway Station, under Jhalda PS and a careful observation from the closet point of view something like the butt of a small fire arms was seen at his waist being kept supported with his paint and it was his firm belief that it was nothing but a fire arms. I asked him to look upon the suspicious person, diarized it vide Jhalda PS G.D.E No. 401 dated 10/11/21 and informed I/C Jhalda PS and as per his direction at 19.55 hrs I, along with C/696-Gorapada Pal, C/1284-Pratapaditya Majhi, C/NVF/1036-Parmatha Kuiry & HG/1636-Harekrishna Ghosh left for Jhalda Railway station to work out the information after briefing them properly about the gravity of the information and plan to nab him. We reached at back side of Jhalda Railway station, under Jhalda PS at 20:05 hrs and keeping the vehicle parked there in a safe distance we preceded to the spot by foot. On reaching there my source identified the person by gesture from a distance and after seeing the Police Party the suspicious person tried to flee away but we nabbed him and on searching Iron Made improvised pipe gun having length approx 10.5 inch with iron butt, firing pin etc with 01 (one) rounds lives cartridges under proper seizure list were recovered from his exclusive possession and unloaded the same safely and on being asked he failed to produce any papers in support of possessing or keeping the said fire arms and he also disclosed his identity as Barun Kuiry (43 yrs) S/O Biswanath Kuiry of Vill-Mohanpur, Kotshila PS, Dist- Purulia. Accordingly I seized the above noted articles from his exclusive possession in-between 20:15 hrs & 20:50 hrs under proper seizure list and being labeled properly. During seizure & label I searched for the local disinterested persons to put sign on the Seizure List as well as Label, but no public witness could be made available. After seizure I arrested him at 20:55 hrs after observing all the legal formalities regarding arrest as his offence comes under the purview of Indian Arms Act.

Hence, I pray that a specific case may kindly be started against him under proper section of law and arrange for its investigation.
