In producing here with 01(One) arrested accused person namely Satya Mahato (22) S/0 Lt. Ambuj Mahato of Vill- Olgara, PO-Khamar, PS- Jhalda, Dist- Purulia and along with 01(one) seized Tractors- WB55A 6109 is attached with sand loaded trolley (approx 100 cft). The fact in brief is that today (16.11.2021) I along with force namely i) C/04-Abadhut Kumar ii) C/696-Gorapada Pal iii) HG/1808-Shyamsing Laya iv) HG/1829-Subodh Ch. Mahato was performing evening mobile duty in PS area vide Jhalda P.S. GDE No- 644 Dated- 16/11/2021 in consonance with Jhalda PS CC No- 4552/21 Dated- 16/11/2021. During my evening mobile duty I received credible source information that one Tractor was lifting & carrying sand illegally and coming from Shyamnagar ghat & coming towards Jhalda Town. Subsequently, I informed you and as per your gracious order, I placed Naka at Gokulnagar more to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the one Tractor was proceeding towards Gokulnagar more. Consequently, we intercepted the said Tractor at before Naka checking point at about 21:35 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police Party drivers and others persons who were on that vehicles (Tractors) started to flee away. After hot chase we managed to apprehend driver of the said tractor namely Satya Mahato (22) S/O Lt. Ambuj Mahato of Vill- Olgara, PO-Khamar, PS-Jhalda, Dist- Purulia On asked, the driver disclosed his identity as mentioned earlier. On demand, he failed to produce any valid papers in respect of the Tractor which is attached with Trolley as well as loaded sand though sufficient time was given. During interrogation, the driver of said tractor confessed that the he along with the owner of the vehicle namely Sanatan Mahato of Vill-Olgara, PO-Khamar, PS- Jhalda, Dist- Purulia by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasoned to belief that he in cahoots with Sanatan Mahato the owner of the vehicle procured the said sand from Shyamnagar Ghat of Subarnarekha River by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo I, seized the vehicle 01 (one) tractor having registration No-WB55A 6109 is attached with sand loaded trolley (approx 100 cft) under proper seizure list in presence of available witnesses duly signed by them and arrested the driver of said tractor namely Satya Mahato (22) S/O Lt. Ambuj Mahato of Vill-Olgara, PO-Khamar, PS- Jhalda, Dist-Purulia under proper arrest memo and informed him the ground of arrest. Thereafter, I brought the said tractor to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the Owner & driver of the said vehicles as they committed offence U/S 379/411/414/120B of the IPC & 21 (4)Mines and Minerals (R&D) Act-1957.
