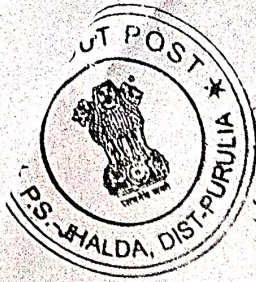

Sir,

In producing herewith one arrested accused person namely Chaitya Mahato @ Nimtoli (76) S/o Late Futka Mahato of Vill.- Bengo, PS-Jhalda, Dist.- Purulia under arrest along with seized articles as per seizer list i.e. approx 05 (Five) liters of illicit distilled liquor (Cholai) in a plastic Jeriken under proper seizure with label.

I, SI Jayanta Kumar Chakraborty of Tulin OP under Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that on 26/11/2021 evening myself along with force C/478 Dipyaban Pratihar & JC/1467 Kamrul Ansary both of Tulin OP were performing mobile duty on Purulia-Ranchi Road vide CC No. 1709/21 dated 26/11/2021 and Tulin OP GDE No. 760 dated 26/11/2021. At about 17:35 hrs I received a credible source information that one Chaitya Mahato is selling "Cholai" in his house at village Bengo illegally. On received such information I informed the matter to IC Jhalda PS and as per his kind direction I immediately moved to Bengo village and held raid in the house of above noted accused person and intercepted him. On being searched we notice one Jeriken loaded with something kept in the corner of the house in concealed condition. On being asked he told that the said Jeriken is loaded with "Cholai" i.e. illicit distilled liquor and was going to sell to the villagers. On demand he failed to produce any license / authority of the said "Cholai" / liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the villages in the village illegally. So, finding no any other alternative way I seized the above noted article from the possession of the above noted accused person and labeled, duly signed by the accused person & witnesses in between 18:15 hrs to 18:25 hrs in which 01 (one) 100 ML bottle of "illicitly distilled liquor (Cholai)" was kept as a sample file with label. During interrogation he confessed his guilt as such I arrested him at 18:35 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Chaitya Mahato @ Nimtoli (76) S/o Late Futka Mahato of Vill.- Bengo, PS-Jhalda, Dist.- Purulia u/s-46A (c) of the Bengal Excise Act 1909.
