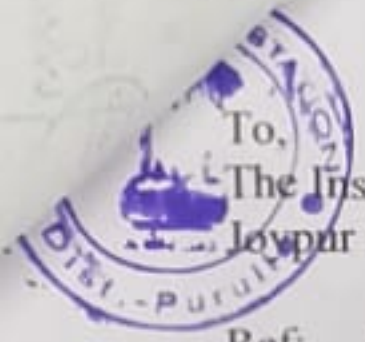

Sub: Prayer for starting a specific case against arrested accused Amarnath Dutta (26 yrs) S/o-Sanjoy Dutta of Garhjoypur PS-Joypur Dist- Purulia.

Sir,

In producing herewith arrested accused Amarnath Dutta (26 yrs) S/o-Sanjoy Dutta of Garhjoypur PS-Joypur Dist- Purulia with arrest Memo, along with seized articles 08 (eight) Kg banned fire crackers in different packet & different company under proper seizure list, I beg to report that, on 03/11/2021 during my Mobile duty received a telephonic information from my source that one person is selling crackers illegally at his shop Laxmimela Bazar. Accordingly I informed the matter to I/C Joypur PS and as per his direction myself along with UC/-Debasish Ghorai NVF/-803 Ankur Ch Mahato started for working out the information vide Joypur PS C.C No-3670/21 dated- 03/11/2021 and briefing them carefully about the information and my plan to catch him red handed. We reached at Joypur Laxmimela Market daily market at his shop "Dutta Packed Center" on 03/11/2021 at 13:35 hrs and proceeded to the spot on feet and as per public information identified the shop. We entered into the shop and detained one person who on asked revealed himself as Amarnath Dutta (26 yrs) S/o-Sanjoy Dutta of Garhjoypur PS-Joypur Dist- Purulia and identified himself as the owner of the shop and when I told him about the information, he fully confessed that he used to sell crackers and on searching the shop recovered (08 (eight) Kg fire crackers in different packet & different company and on being demanded he failed to produced any license or constitutional papers in favour of keeping, storing or selling any crackers or combustible or fire articles and also confessed that inspite of knowing it fully well that it is strictly illegal and unlawful to sell, keep or store, he had been selling those crackers after having a huge store of it in the shop from the past few days. Accordingly I seized the above mentioned fire crackers from his exclusive possession after furnishing proper seizure list and arrested him accordingly for his negligent conduct with respect to fire or combustible or explosive substances which can endangered human life. He also violated the order of Pollution Control Board of West Bengal and Hon'ble High Court Calcutta Memo No-329-2L/WPB-F(V)/2021 Dated-30/10/2021 in c/w order of Hon'ble High Court Calcutta dated-29/10/2021 passed in W.P.A (P) No-282 of 2021 and Directions of the State Board U/S-31(a) of Air (Prevention & Control of Pollution) Act 1981 & Rules made thereunder.

Hence he is liable for prosecution U/S-188/ 285/286 IPC and Section 24/26 West Bengal Fire Service Act. So I pray that a specific case may kindly be started against above noted arrested accused person.
