That, the Complainant thereafter finding no other alternative informed the Local Police Station and ~~xxxxxx~~ reported the incident ~~xxxxxxx~~ where the Police assured that they would take necessary legal action against the Accused persons after due enquiry, but when the Petitioner/Complainant became very much reluctant that the matter referred to Joypur Police Station and thereafter the matter referred to the Superintendent of Police, Purulia on 05-10-2021, but of no ~~good~~ good.

5. That, the Complainant is still suffering from mental pain and also in a fear mood due to the threatening of the Accused persons who are very adamant in nature in the locality and also enmity with the Complainant and accordingly the Complainant is filing the Complaint before the Id. Court.

In the circumstances, it is, therefore, prayed that your Honour may be pleased to send the Petition of Complaint to the Inspector-in-Charge of Joypur Police Station treating as an F.I.R. Under Section 156(3) of Cr.P.Code for investigation.

The above named Complainant begs to state as follows : -

1. That, the Complainant and his other relatives have planted various type of trees including some good number of Arjun Trees, Sishu Trees, Mango Trees and other trees and these are grown well and that the Complainant and his relatives are possessing these trees in various ways and the Accused persons have every knowledge about the possession of these trees planted by the Complainant and his relatives. On the other hand the Accused persons have no manner of possession over any of the trees in any manner.
2. That, on the date of incident i.e. on 30-09-2021 all on a sudden the Accused persons by forming an unlawful assembly armed with Iron Rods (Sabal) Gainta and Kadal and Lathi and other weapons criminally trespassed in th the land and cut and removed the trees grown by the Complainant of which the value of these trees is about Rs. 40,000/- (Rupees Forty Thousand) in all.
3. That, the Complainant and other Witnesses on hearing such illegal acts of the Accused Persons rushed to the place and objected the same when the Accused Persons assaulted the Complainant with fist and blows and also threatened him with dire consequences and also gave out that if the Complainant dare to protest in that case they would finish the life of the Complainant.
