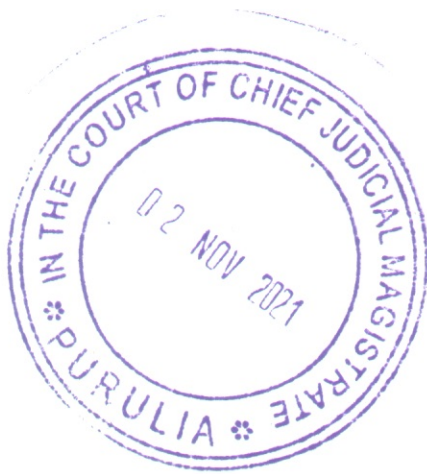

That the complainant submits that on 2/10/2021 while the complainant was cooking at about 7 A.M. morning the accused persons ~~submit~~ suddenly entered in to the house of the complainant and found the complainant was busy in cooking the accused persons namely Kailash took Iron rod and butted on head of the complainant and the other accused persons started abusing the complainant with filthy language and the complainant became senseless.

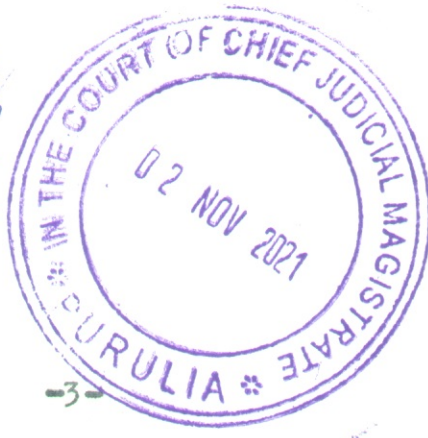
4. That at the time of the incident the mother and the brother of the complainant was present who tried to resist them but the accused persons were in doing in nature and tried to assault the mother of the complainant.

5. That the mother of the complainant and her brother took the complainant to the Joypur P.H.E. and thereafter the complainant was referred to Deben Mahato Sadar Hospital Purulia and there the complainant was admitted and ultimated she was discharged i on 4/10/2021 and the Doctor stitched the injury part on the head of the complainant.

6. That the complainant lodge a complaint before the Joypur p.s. against the accused person but the police did not take any steps against the accused person the reason best known to the police.
7. That subsequently the complainant submitted an application before the superintendent of police on 4.10.2021 treating the same as the F.I.R.
8. That it is submitted that while the complainant was admitted in Sadar Hospital, the media was ~~xxx~~ called by the complainant and her family and it was published in Purulia Darpan the local ~~xx~~ weekly paper about the incident and the treatment of the Doctor.
9. That the complainant submits that the golden ear rings and a golden chain has been snatched by the accused persons while she was senseless and left the place.
10. That the accused persons have committed an offence u/s ~~107/128/309/354/307/34.I.P.C.~~ *12 charge*

It is therefore prayed that your honour will be graciously pleased to treat this petition as an F.I.R. u/s 156(3) Cr.P.C. and necessary order may be passed.
