I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Getredhar Mahato, S/O-Lt. Ravi Mahato of village-Kulara, P.S- Joypur, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 24.11.2021 at about 12.05 P.M. I Sri Nilanjan Kumar Mondal, DE & Station Manager, Joypur CCC along with O1.Raushan Kumar, JE(E),GR-II, Joypur CCC O2.Ganesh Mahato, Gr1 TSH, Joypur CCC, entered the premises of Getredhar Mahato, S/O-Lt. Ravi Mahato of village-Kulara, P.S- Joypur, Dist- Purulia and found Getredhar Mahato, S/O-Lt. Ravi Mahato was enjoying electricity unauthorizedly drawing power from the LT/DH line of WBSEDCL through Red & Green Cu wire 6 meters by means direct hooking to his domestic premises and connected load found 0.15 KW. As Getredhar Mahato, S/O-Lt. Ravi Mahato committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of O1.Raushan Kumar, JE(E),GR-II, Joypur CCC O2.Ganesh Mahato, Gr1 TSH, Joypur CCC. The inspection team left the premises at 12.35 P.M.
