I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Ananda Mahato, S/O-Shambhu Mahato of village-Kulara, P.S- Joypur, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 24.11.2021 at about 12.42 P.M. I Sri Nilanjan Kumar Mondal, DE & Station Manager, Joypur CCC along with O1.Raushan Kumar, JE(E),GR-II,Joypur CCC O2.Ganesh Mahato, Gr1 TSH,Joypur CCC, entered the premises of Ananda Mahato, S/O-Shambhu Mahato of village-Kulara, P.S- Joypur, Dist- Purulia and found Ananda Mahato, S/O-Shambhu Mahato was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through PVC Black colour 4 Sq mm cable 4 meters by means direct hooking to his domestic premises and connected load found 0.2 KW. As Ananda Mahato, S/O-Shambhu Mahato committed theft of electric power. So, I seized the following articles after preparing the seizure list in presence of O1.Raushan Kumar, JE(E),GR-II,Joypur CCC O2.Ganesh Mahato, Gr1 TSH,Joypur CCC. The inspection team left the premises at 1.12 P.M.
