On 24.11.2021 at about 12.42 P.M . I Sri Nilanjan Kumar Mondal, DE & Station Manager, Joypur CCC along with 01.Raushan Kumar, JE(E),GR-II,Joypur CCC 02.Ganesh Mahato, Gr1 TSH,Joypur CCC , entered the premises of Ananda Mahato, S/O-Shambhu Mahato of village-Kulara, P.S- Joypur , Dist- Purulia and found Ananda Mahato, S/O-Shambhu Mahato was enjoying electricity unauthorizely drawing power from the LTOH line of WBSEDC through PVC Black colour 4 Sq mm cable 4 meters by means direct hooking to his domestic premises and connected load found 0.2 KW. As Ananda Mahato, S/O-Shambhu Mahato committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of 01.Raushan Kumar, JE(E),GR-II,Joypur CCC 02.Ganesh Mahato, Gr1 TSH,Joypur CCC.The inspection team left the premises at 1.12 P.M.
