Surendra Mahato of village-Kulara, P.S- Joypur , Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 24.11.2021 at about 1.17 P.M. . I Sri Nilanjan Kumar Mondal, DE & Station Manager, Joypur CCC along with 01.Raushan Kumar, JE(E),GR-II,Joypur CCC 02.Ganesh Mahato, Gr1 TSH,Joypur CCC , entered the premises of Ramesh Mahato, S/O-Lt. Surendra Mahato of village-Kulara, P.S- Joypur , Dist- Purulia and found Ramesh Mahato, S/O-Lt. Surendra Mahato was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through red colour Cu cable 5.5 meters by means direct hooking to his domestic premises and connected load found 0.2 KW. As Ramesh Mahato, S/O-Lt. Surendra Mahato committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of 01.Raushan Kumar, JE(E),GR-II,Joypur CCC 02.Ganesh Mahato, Gr1 TSH,Joypur CCC.The inspection team left the premises at 1.40 P.M.
