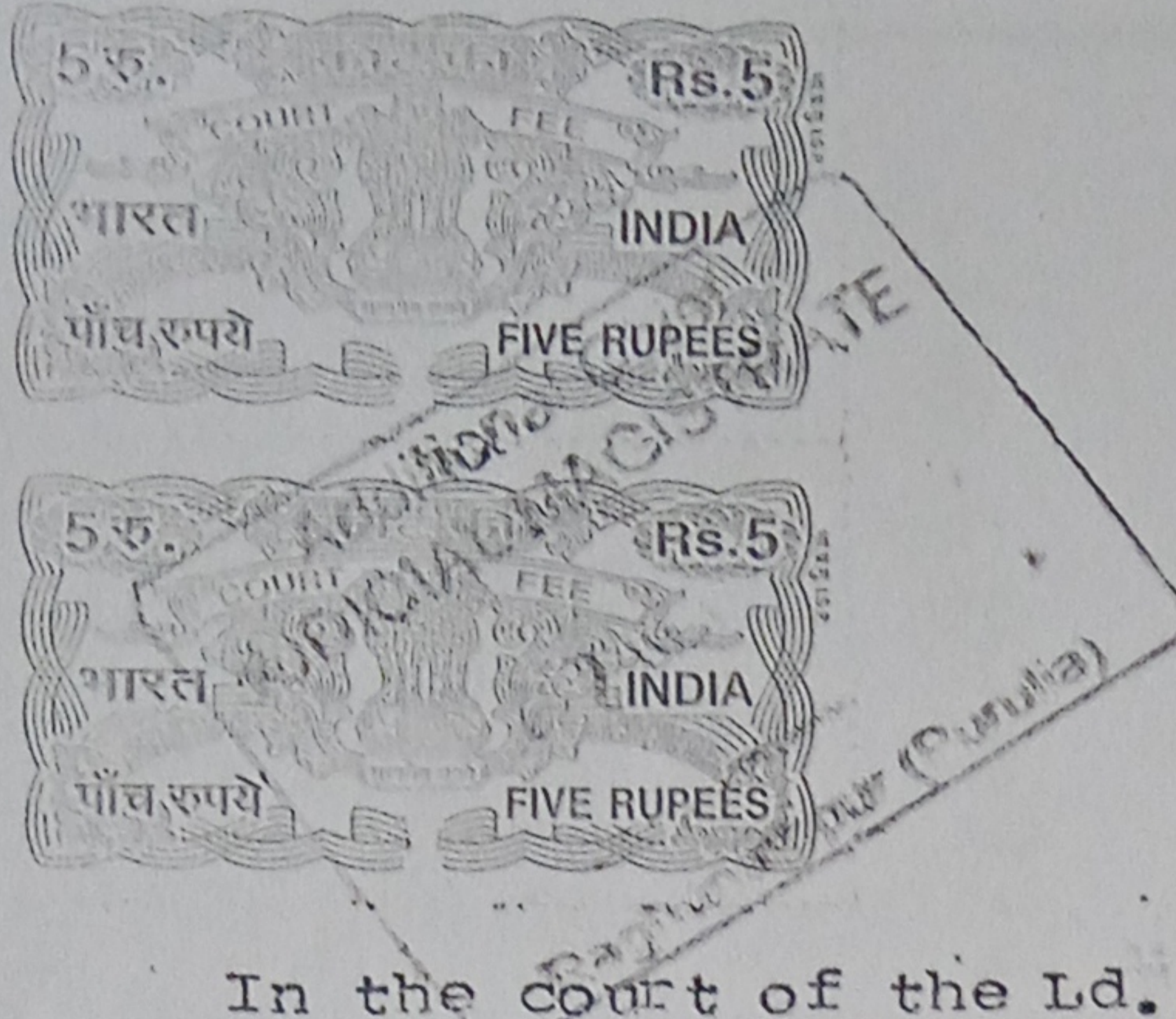

The complainant most respectfully begs to state as follows:-

1. That the complainant is the permanent resident of village:- Bhalagora, under P.S. Kashipur, Dist: Purulia within the jurisdiction of this court.
2. That on 12-04-2021, the petitioner alongwith his uncle/brother nephew were all digging their ancestral property of Pathariyagora under mouza-76 plot no. :-384 area: 1.16 acre for making boundary.
3. That at about 9 A.M. that very day the above mentioned persons of Pathariyagora village, under P.S. Kashipur opposed the complainant in making boundary. The accd. persons threatened the petitioner/complainant with his uncle, brothers, nephew to kill if the said work was not stopped immediately.
4. That the complainant continued in making the said boundary without paying any heed to threatened of the accd. persons.
5. That on very date at about 1.30 P.M. suddenly the said accd. persons namely Dilip Mahali, Chandicharan Bauri assaulted the complainant with lathi, rod and other weapons with a conspiracy and rest of the accd. persons hit others with fist and blow.
6. That the accd. persons mischieved and destroyed five cycles of the complainant with rod and axe etc. After a while the family members of the accd. persons with illmotive came and instigated the incident.
7. That the complainant after taking serious injury was taken to Kolloli Hospital, Kashipur and hospitalised.
