This is to intimate you that four days ago i.e on 18.11.2021 at about 12pm on information a raid has been conducted by the special task force headed by shri Saibal Mitra (SDLLRO Sadar) formed by the Honorable District Magistrate Purulia along with the undersign and Revenue Officer and others staff of BL&LRO office Kashipur. At the chuna village, chuna mouza, quartz are mined illegally by some unknown person during the raid. People who are related with the illegal mining had escaped the spot as soon as the task force team reached the spot. A caterpiller vehicles (bearing name – Satyam Infra Project, ph-9800274081,L&T –Komaisu, PC-200) had been found approx 700mtr away from the mining spot.

Team of BL&LRO, Kashipur has been seized the caterpillar and handed over to kashipur PS for safe custody.
