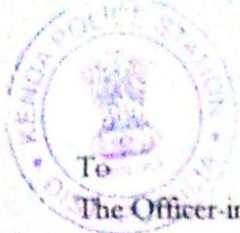

Sub: Request for lodging FIR against arrested accused person.

Sir,

In producing herewith the arrested accused person namely Prasenjit Dey (34) S/o- Lt.-Bikash Chandra Dey of Vill- Turang, PS- Kenda, Dist- Purulia along with seized articles viz. i) 05 packets of Crackers designed as Dulal Chocolate @ 10 Pcs each = 50 Pcs, ii) 07 packets of Crackers designed as Rolex Chocolate @ 12 pcs each = 84 Pcs iii) 05 packets of Crackers designed as Classic King size Chocolate @ 10 pcs each = 50 Pcs iv) 02 packets of Alar Rasnay (Tubri) Big Size @ 12 pcs each = 24 Pcs v) 04 packets of Alar Rasnay (Tubri) small Size @ 10 pcs each = 40 Pcs vi) 06 packets of Crackers designed as Mantu Chocolate @ 10 pcs each = 60 Pcs vii) 04 packets of Flower Pots Big @ 10 Pcs each = 40 Pcs viii) Bijli Crackers - 01 Pkt @ 100 Pcs along with all connected papers. I beg to report that today (03.11.2021) at 15:35 hrs duty officer PSI SK Rahaman received a telephonic information from reliable source that one person is selling crackers illegally in his shop styled as Manajeet Dey Varieties store of Turang village. This refers to Kenda PS GDE No-84 dated 03.11.2021. Duty Officer informed the matter to O/C Kenda PS and as per order of OC Kenda PS I, ASI Nimai Rajwar along with C/181 Rabban Sekh, C- 2644 Mithun Duley, HG-1425 Ashoke Kr. Mahato started for work out the information vide Kenda PS CC No 1277/21 dtd 03.11.2021 and GDE No. 88 datd- 03.11.2021 and briefing them carefully about the information and my plan to catch him red handed.

After that at 17:05 hrs we arrived at Turang village and held raid at shops namely Manajeet Dey Varieties store and search and we found the above noted articles were stored inside of the shop. We detained one person who on asked revealed himself as Prasenjit Dey (34) S/o- Lt.-Bikash Chandra Dey of Vill- Turang, PS- Kenda, Dist- Purulia and identified himself as the owner of the shop and when I told him about the information, he fully confessed that he used to sell crackers. On being demand he failed to produce any license or constitutional papers in favour of keeping, storing or selling any crackers or combustible or fire articles and also confessed that he had been selling those crackers after having a huge store of it in the shop from the past few days. Accordingly I seized the above mentioned fire crackers from his exclusive possession after furnishing proper seizure list duly signed by the witnesses. After sufficient evidence established, I issued him notice U/S 41A Cr.P.C but he refused to receive. Hence I arrested him after observing all the formalities of arrest. It is strongly established that the said accused person committed an offence for keeping huge amount of fire crackers causing negligent conduct with fire crackers which may cause endangering life of human and damage to property and selling of such fire crackers illegally at his above noted shop without license.

Under the above circumstance, I submitted this complaint and with a prayer to start a case against charged person Prasenjit Dey (34) S/o- Lt.-Bikash Chandra Dey of Vill- Turang, PS- Kenda, Dist- Purulia under the proper section of laws.
