Sir,

In producing herewith one seized vehicle (Tractor) without number plate bearing Chassis No. MBNABAEXKMRD06743 and Engine No. RMD2EAN2739 attached with trolley loaded with appx 100 Cft. sand. The fact of the case in brief is that on 10/11/2021 I along with C/ 631 Tulsidas Satpati and C/2519 Arun Duley of Kenda PS were performing night mobile duty. During mobile duty on 11/11/2021 at about 02.15 hrs. when we reached near at Bansa village Morh found that the above noted tractor was coming from Kansai river side under Kenda PS. On seeing the Police party driver of the said vehicle stopped his tractor in a distance and he fled away after keeping the tractor near Bansa village Morh. We searched the said tractor and found that the tractor was loaded with sand. Hence we waited there some times and held an enquiry about the said tractor but none turned up and demanded as actual owner of the said tractor loaded with said sand and it ascertained that the owner and driver of the said tractor loaded the said sand by illegal manner for selling the same to make profit by dishonestly in a clandestine business. So seized the tractor bearing Chassis No. MBNABAEXKMRD06743 and Engine No. RMD2EAN2739 loaded with sand approx. 100 CFT without any number plate under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranged driver from my source and brought the tractor at Kenda PS. So there have sufficient reason to belief that driver and owner of the said seized tractor procured the said sand by fraudulently means or theft by any means for transporting the same to clandestine business.

Under the above facts and circumstances kindly take lawful action against the owner and driver of the tractor having Chassis No. MBNABAEXKMRD06743 and Engine No. RMD2EAN2739 attached with trolley & loaded with sand approx. 100 Cft.
